In compliance of the Ministry of Environment and Forests (MoEF), Government of India letter No.11-98-FC(Pt.), dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlements of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter.

Dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 1. in Gangamula Thanda 0.0838 Ha of forest land in Janagam-I Reserve forest, 2. in Kadilabavi Thanda GP 0.2467 Ha of forest land in Rachakonda Compartment No.201, 203, 204 and 206 reserve forest, 3. in Rachakonda GP 0.0116 Ha of land in Rachakonda compartment No.208 reserve forest proposed total 0.3421 Ha of forest land to be diverted in favour of Telangana Fibre Grid Corporation Ltd for providing high speed internet connection to every household, government institutions and private enterprises across the Rural part of the state through Optical fiber cable.

It is further certified that,

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.3421 Ha of forest area proposed for diversion. A copy of records all consultations and meetings of the Forest Rights Committee (s), Gramasabha (s) are enclosed as Annexure I to Annexure —
- (b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gramasabhas have given their consent to it.
- (c) The proposals does not involve recognized right of Primitive Tribal Groups and Pre Agricultural communities.
