

According to the accorded General Approval (Stage-1) under section II of the Forest (Conservation) Act 1980, Net Present Value (NPV) for 0.27 ha of forest land through RTGS is deposited to the State CAMPA A/C No. 150796226491884 of Corporation Bank, FCS Bangalore dated 01/02/2018 and the General Approval (Stage - 1) Order and Working Permission issued by the State Government was effected from the 2<sup>nd</sup> February 2018 for 1 (One) year. According to the above Order, the position is under construction.



**No.27/20/2017-For&Envnt:** In continuation of this Government's Orders of even No. dated 8/01/2018, the Competent Authority hereby approved working permission allowing Commencement of work by diversion of 0.27 ha of forest land at Nongmaiching Hills, Keirao, Imphal-East, subject to fulfillment of the following conditions

- 1) The Working Permission granted shall be valid for 1(one) year with effect from the date of issue of order,
- 2) State Forest Department shall upload the copy of "**General Approval (Stage I)**" order and working permission issued by the State Government to the website of the Forest Department to ensure availability in the public domain.
- 3) The UA shall submit the copies of the IPA letter and the working permission to the Head of the local bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
- 4) UA and State Forest Department shall submit the compliance report of all conditions stipulated in the "**General Approval (Stage I)**" order No.27/20/2017-For&Envnt. Dated 8<sup>th</sup> January, 2018 within 1(One) Year for obtaining final approval of the project from State Government.
