I invite kind attention to the reference cited.

In the reference cited, the Sub Collector, Madanapalli has reported that, the work "for Improvements to Royalpeta-Madhavaram road (via) Penugolakala from Km:0/0 to 16/0 in Chittoor District" was sanctioned RIDF-XII; that the work could not be carried out from KM 9/9 to 18/8 since the road is passing through Reserve Forest and the alienation of forest land was proposed, subject to allotment of alternate land as Compensatory Afforestation;; that the Tahsildar, Baireddipalle mandal has inspected the lands in S.No.85 measuring an extent of Acs.279.88 cents of Kaigal Revenue village , classified as Grazing Ground poramboke on 04.05.2017 and the status of the lands are as follows.

1. Extent under cultivation (Sevaijamadars) :88.62 acres.
2. Land alienated to Jiddu Krishnamurthy foundation :93.08 acres.
3. River and Govt., land :98.18 acres.
4. Total :279.88 acres.

The Sub Collector, Madanapalli has further informed that, after sub division, the Tahsildar, Baireddipalli has proposed an extent of 11.89 acres of land S.No.106 as stated t above and reported that, the land is quite suitable for compensatory afforestation and there are no DKT pattas issued to anybody so far and the land is free from encroachments ; that the Tahsildar also reported that the Forest authorities have also agreed to take the land for compensatory afforestation.

The Sub Collector, Madanpalli has requested to take necessary further action for allotment of above land in favour of forest department as compensatory afforestation.

In view of the above, I request that, necessary orders may be issued, for transfer of lands measuring an extent of Acs.11.89⁵cents in S.No.106 of Kaigal village of Baireddipalli Mandal in favour of Forest Department.
