

The proposed beach resort and wellness centre is situated in Kagal Village, Kumta Hobli, Uttara Kannada District is enveloped by coastal at one end and forest land at the other sides, thus making it a land locked area. Total project area is about 21.7296 Ha, out of which 20.74 Ha is Non-forest land which is the project site and 0.9896 Ha of forest land which is the approach road for the project site. The proposed approach road is the existing path which is used by public for general works. So we have proposed to utilize the same existing path as approach road to reach to our project site. Since there were no alternative roads we proposed to use the existing path way. We have considered a minimal alignment with a total area of 0.9896 Ha of an existing mud road so that the impact on the forest boundary is least/negligible.
