Following decisions were taken in the meeting:-

Agenda item no. 1: Confirmation of minutes of FC 712/05.12.2016.

Summary record of decisions of the meeting of FC 712 dated 05.12.2016 issued vide letter no. F.3 ()/FC 712/2016-17/3315-65 dated 07.12.2016 were confirmed.

Agenda item no. 2:
Approval of price bid for the work of "works related to Reorg. of UWSS, Jodhpur viz. clear water transmission system " CWTM-2 (NIT No.-(1FB) UWSS/Ju/AFD/07

The deferred agenda item of FC712/05.12.2016 was considered in light of the comments of TM and FA&CAO and presentation made by CE(P), PHED, Jodhpur. During presentation, it was informed that 4 tenders were received for the work and 2 were qualified for opening of price bids and the offer of M/S Devendra Construction Co., Jodhpur for Rs 313191423.82 is lower than the estimated NIT cost. It was also informed that likely expenditure of all packages under Phase-I (14 nos.) and Phase-II (8 nos.) shall be within A&F amount of Rs. 740.50 Crs.. In view of above, he recommended for approval of the lowest bid. The agenda item was deliberated in detail. During deliberations, CE(P), Jodhpur

informed that the work is being funded through AFD and NOC of same has been received from AFD and adequate budget is available for execution of the work and also reiterated that the lowest offer is workable and justified. He also confirmed fulfilment of provisions of RTPP Rules, 2013 in the bidding process. After deliberations, it was decided to approve the lowest offer of M/S Devendra Construction Co., Jodhpur for Rs 313191423.82 as recommended by CE(P), Jodhpur subject to following:-

- Availability of budget for execution of work during CFY and subsequent years of execution shall be ensured.
- II. CE(P), Jodhpur shall ensure that clearances from all the agencies and land acquisition are obtained well in time, so as to avoid any hindrance during execution of the work.

Agenda item no. 3:
Work of construction of raw water storage tank, slow sand filter, CWR, pipelines and shallow tubewell in village Sai Chakos of village Dharusar of District Bikaner under Border Area Development Programme (NIT no. 25/2016-17) M/s M.M. Gharsana

The agenda item was considered as per presentation made by CE(R), PHED, Jaipur. During presentation, it was informed that though approval of tender for the work was in his power but action on the tender could not be taken within the prescribed period of 50 days due to time consumed in disposal of appeal filed by one of the bidder regarding its disqualification. As the tender could not be decided within prescribed period as per rules due to reason mentioned above, he requested to condone the delay in approval. The agenda item was deliberated in detail. In view of the reason informed by the CE, after deliberations, it was decided to condone the delay in deciding the tender within prescribed period at the CE's level. CE(R), Jaipur shall take appropriate action on the tender within 15 days.

Agenda item no. 4-11: Approval of price bids for the Work of providing, designing, installation and commissioning of solar energy based water pumping system (with De-fluoridation units 1000 LPH) including 7 years O&M (NIT No. 13-14 and 16-21/2016-17)

The agenda items were considered in light of comments of TM and FA&CAO RWSSMB, reply of observation of TM given by CE(R) vide his office letters dated 20.12.2016 and presentation made by CE(R), PHED Jaipur. During presentation, following were informed by CE(R):-

- i. Tender were invited by respective ACEs for the work of solar energy based bore well pumping system with De Fluoridation units with estimated cost as per their estimation and anticipated number of solar DFUs to be installed with different head ranges.
- ii. Subsequent to floating of NITs, again number of solar DFUs to be installed with different head range was reviewed by the ACEs and in BoQs the number of DFUs to be installed was revised. Such revision was mainly made

- under NIT No. 13,14 & 17. Possibility of further revision in category wise DFUs was also informed.
- iii. The rate justification was communicated to Board Office vide CE(R) letter dated 11.11.2016. The same was based on assessment done by ACE, PHED Region II Jodhpur for NIT 17 & 18, and being similar nature of work, the same rates were assumed reasonable for other NITs also.
- iv. The lowest rate received for different category of solar DFUs in all NITs is in the range of 0 to 4.08% variation except NIT no 18 of District Sirohi. The reason for low unit rates quoted in NIT 18 by the bidder is probably due to smaller district having concentrated work in the region and the bidder having all the infrastructure facility available in the district which may reduce expenditure in unit installation & maintenance.
- v. The category wise unit rates received across all these 8 NITs is within 4% above previous rates approved for similar work by FC697/17.2.2016 which seems reasonable due to revision in scope of work of the current NITs i.e. increase in O&M from 5 to 7 years, additional provision of UV and Street light and price escalation since last NIT.
- vi. The rates received for various categories of solar DFUs are lower than the workout justified cost (rate) from 1% to 12.92% below.

The agenda item was deliberated in detail, during deliberation; CE (Rural) informed that adequate budget is available for execution of the work under funds of NITI Aayog. In view of above, he recommended approval of the lowest offers being reasonable and justified. He also confirmed fulfillment of provisions of rule 43 and 68 of RTPP Rules, 2013.

After deliberation it was decided to approve the category wise unit rates of the lowest offer as per annexure-1/AI 4-11/FC/713/21.12.2016, subject to the following:

- Availability of budget for execution of work during CFY and subsequent years of execution shall be ensured.
- Technical sanction shall be issued by the competent authority for individual installation to confirm category of the solar plant (head range) as per detailed work order.
- The work shall be executed within the A&F sanctioned amount. Revised sanction shall be sought from SLSSC in case of any excess as per prevailing rules.

Agenda item no. 12: Work of water sample collection, sanitary survey of water sources, sample testing, O&M of already established block level laboratories. uploading of sample testing results on IMIS/PHED website, documentation as well as GIS mapping to locate each sources in Distt. Jaipur, Alwar, Dausa, Sikar and Jhunjhunu (Region Jaipur) for 3 years (NIT no. 01/2016-17

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(R), PHED, Jaipur and Chief Chemist, PHED, Jaipur. During presentation, it was informed that 3 tenders were received for the work and only one bidder was qualified for opening of price bids and the offer of the only qualified bidder M/s EL-TRONICs, Jaipur for Rs 19,78,56,000.00 is considerably higher than the estimated cost of NIT i.e. Rs. 1325.00 lacs. It was also informed that scope of work was revised after floating NIT in view of various issues raised by the tentative bidders in pre-bid meeting but estimates/cost of work could not be revised accordingly. The agenda item was deliberated in detail. In view of very high offer than the estimated NIT cost, after detail deliberations, it was decided to file the tender and to call fresh tenders after preparation of detailed estimates based on new NRWDP guidelines.

Agenda item no. 13: Ex-post facto A&F sanction for TOW carried in UWSS Bhilwara & Gangapur towns by road during Summer 2016 (EC Rs. 103.56 lacs)

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(HQ), PHED, Jaipur. During presentation, it was informed by the CE that transportation of water was carried out in UWSS Bhilwara & Gangapur by road during Summer 2016 for Rs. 103.56 lacs as per provision under SDRF funds after approval and directions from District Collector Bhilwara. The payment of work could not be done under SDRF funds due to objections of Relief Department as water being supplied through distribution system after filling of reservoir through tankers and revenue of same was received by the Department. CE (HQ) also informed that Pr. Secretary vide ID no. 2052/PS/PHED-GWD dated 28.10.2016 has directed to make payment of the already carried out TOW under department fund and get the same reimbursed later. In view of objection by Relief Department and directions from Pr. Secretary, he recommended to accord ex-post facto sanction of Rs 103.56 lacs for TOW carried out in UWSS Bhilwara by road during 17.05.2016 to 30.06.2016 (Rs. 60.27 lacs) and in UWSS Gangapur during 15.04.2016 to 10.07.2016 (Rs. 43.29 lacs) under budget head State Plant Urban-Summer Contingency. The agenda item was deliberated in detail. After deliberations, following were decided:

- I. To accord ex-post facto A&F sanction for Rs. 103.56 lacs for TOW carried out in UWSS Bhilwara by road during 17.05.2016 to 30.06.2016 (Rs. 60.27 lacs) and in UWSS Gangapur during 15.04.2016 to 10.07.2016 (Rs. 43.29 lacs) under budget head State Plant Urban-Summer Contingency..
- II. Payment against the sanction shall be made after due verification of bills as per 3 coupon system duly verified by concerned officer of PHED and ensuring the financial rules.
- III. The above sanction shall stand cancelled after if payment of this TOW is made under SDRF by Relief Department.

Agenda item no. 14:
Transportation of water through tankers from Dec., 2016 to March, 2017 to combat the drinking water problem in urban areas of Dausa district (Confirmation of on File approval)

The agenda item was considered as per presentation made by CE(HQ), PHED, Jaipur. During presentation, it was informed that approval for transportation of water through tankers from Dec., 2016 to March, 2017 to combat the drinking water problem in urban areas of Dausa district has already been accorded on file by Pr. Secretary, PHED and Chairman, FC on 06.12.2016 and requested to concur the same by the Committee. The Committee noted the 'on file' approval already accorded by the Chairman FC and concurred the same.

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(HQ), PHED, Jaipur. During presentation, it was informed by the CE that transportation of water was carried out in UWSS Bandikui, Baswa & Dausa by road from Aug., 2016 to Nov., 2016 for total Rs. 159.39 lacs in compliance to the directions of group of Hon'ble Ministers and Pr. Secretary, PHED on dated 18.06.2016 and 02.07.2016 respectively. In view of above, he recommended to accord ex-post facto sanction of total Rs 159.39 lacs for TOW carried out in Bandikui (Rs.37.54 lacs), Baswa (Rs. 32.24 lacs) & Dausa (Rs. 89.61 lacs) by road during from Aug., 2016 to Nov., 2016 under budget head State Plant Urban. The Committee viewed the matter seriously and in future timely sanction should be obtained from competent authority. The agenda item was deliberated in detail. After deliberations, following were decided:

- To accord ex-post facto A&F sanction total Rs 159.39 lacs for TOW carried out in Bandikui (Rs.37.54 lacs), Baswa (Rs. 32.24 lacs) & Dausa (Rs. 89.61 lacs) by road during from Aug., 2016 to Nov., 2016 under budget head State Plant Urban.
- II. Payment against the sanction shall be made after due verification of bills as per 3 coupon system duly verified by concerned officer of PHED and ensuring the provisions of financial rules and SOP of the Department.

Agenda item no. 16:
Procurement of ISI marked AC pressure pipes manufactured by using fly ash size 80 to 125mm against NIT no.
AC pipe/2016-17/38 dated 27.09.16, qualifying bid opened on 09.11.2016 and price bid opened on 30.11.2016

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(HQ). During presentation, it was informed by CE(HQ) that 2 bids were received against the NIT and both the bids were qualified for opening of price bids and the lowest rates received for all class of pipes are 8.21% to 8.49% higher than the assessed rates. He requested to approve negotiations with the lowest bidder(s) to lower down the rates. The agenda item was deliberated in detail and after deliberations, it was decided to conduct negotiations with the lowest bidder(s) by Standing Negotiation Committee for lowering the rates.

Agenda item no. 17: Construction of 6 CWR (26 ML total capacities) at all head works, construction of service reservoirs at locations under Phase-I of the project area and construction of 6 nos. of head works complete and O&M for 24 months. ACE, Jaipur Region-II decision matter on pertaining cancellation of work. (NIT no. 03/2013-14) DB Civil Special Appeal (writs) no. 584 / 12.07.2016

The agenda items was considered as per presentation made by CE(HQ), PHED, Jaipur, ACE-II, PHED, Jaipur and SE, Project Circle, Jaipur City. During presentation, it was informed that instant proposal has been submitted in compliance to decision of FC709 dated 19.09.2016 for consideration of FC after giving a Show Cause Notice to M/S Vishnu Prakash R Pungalia, Jodhpur in compliance to the order passed by Hon'ble High Court on DB Civil Special Appeal (Writs) no. 584/2016 and analysing the reply submitted by M/S Vishnu Prakash R Pungalia on the same. Following was also informed:

 Firm has not submitted copies of work orders executed in FY 2012-13 carried out for private parties but has submitted income tax assessment order for FY 2012-13 (Assessment Year 2013-14) wherein the Income Tax Department has assessed the firm for turnover which is more than Rs. 203.80 Crs. and income tax liability of the firm seems to be fulfilled.

 Following works were awarded to M/S Vishnu Prakash R Pungalia considering annual construction turnover of FY 2012-13 in PO and these works are under progress:

- M/s VPRPL, Jodhpur was disqualified in four works namely Cluster distribution system of 71 villages from Pokran-Falsoond-Balotra-Siwana lift project, RWSS RGLC RD 177.5 Tinwari-Mathania-Osian-Banwri-Bhopalgarh, Reorg. of UWSS, Pratapgarh and Aug. of Masaniya HW at Kishangarh on account of annual construction turnover of FY 2012-13.
- In two works namely Shyagarh WSP and Water Supply Project, Barmer, M/S VPRPL participated but could not be awarded due to matter being subjudice.
- FC was further informed about the position regarding Jodhpur Water Supply Project, Barmer Part-C wherein price

bids of three bidders have been opened so far and the price quoted by lowest bidder, JV of M/s VPRPL and M/s Vatech Wabag is lower by Rs. 155.77 Crs. as compared to second lowest bidder. Another bid by M/S GVPREL — Dara JV is yet to be opened. Disputes regarding M/s VPRPL is expected to be resolved soon following which final decision of the tender is to be taken early.

The agenda item was deliberated in detail. During deliberations, following was observed by the Committee:

- Income tax assessment of the firm was made by Central Government Department i.e. Income Tax Department which is authenticated.
- Out of 4 works awarded to M/s VPRPL on the basis of construction turn over FY 2012-13, 3 nos. works will be completed in Jan., 2017 and remaining one work will be in Sept. 2017.
- The works which were not awarded are under litigation.

After detail deliberations, following was the view of Committee:

- Assessment made by IT Department for FY 2012-13 is sufficient to meet out Financial criteria.
- 4 works awarded to M/s VPRPL on the basis of construction turn over FY 2012-13 will also fall under dispute and may result more litigation.
- In case action against the firm is initiated based on construction turn over of FY 2012-13, progress of 4 works awarded based on FY 2012-13 will hamper a lot which will not be in the interest of Projects and also in the interest of Public.
- Expenditure incurred in above projects so far will become unutilized in case action against the firm is taken based on construction turn over of FY 2012-13.

Looking to the facts and circumstances outlined above, FC, after detailed deliberations decided that presently there appears to be insufficient ground to continue with the process of cancellation of contract and action for debarment etc. against the firm M/s VPRPL, Jodhpur as contained in the department's show cause notice no. 7825-31 dated 03.08.16. Therefore, the work order dated 14.08.14 issued by ACE, Jaipur Region-II to M/s VPRPL remains operative.

Agenda item no. 29: Price bid for the work of reorg. of UWSS Bundi & UWSS Baran (under AMRUT) with 7 years O&M NIT No. 13/2016-17 The agenda item was considered in light of the comments of TM and FA&CAO, RWSSMB and presentation made by CE(R), PHED, Jaipur and ACE, PHED Region, Kota. During presentation, it was informed that 2 tenders were received for the work and both were qualified for opening of price bids. It was also informed that as per directions of Pr. Secretary, PHED, negotiations were conducted by the Standing Negotiation Committee on 19.12.2016 and the bidder reduced its offer from Rs. 14319.11 lacs to Rs. 139,61,17,895.62. It was further informed that Standing Negotiation Committee did not consider the negotiated offer as reasonable being much higher than the estimated cost of the work. CE(HQ) requested for filing the tender and to grant permission for retendering. The agenda item was deliberated in detail. As the negotiated offer of the bidder was considerably higher than the worked out estimated cost, after deliberations, it was decided to file the tender and re-invite fresh tenders for the work as recommended by CE(HQ).

Agenda item no. 30: Price bid for execution of the work of aug. of RWSS Atru-Khedliganj Distt. Baran with one year defect liability period and 10 years O&M NIT no. ACE/KT/12/2016-14 The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(R), PHED, Jaipur. During presentation, it was informed that 7 tenders were received for the work and 4 were qualified for opening of price bids and the offer of M/S B&G Construction Co., Jodhpur for Rs 11,42,24,824.00 is lower than the estimated NIT cost. They also informed that though the lowest offer is lower than the estimated cost, however, the same is workable. In view of above, he recommended for approval of the lowest bid. The agenda item was deliberated in detail. During deliberations, CE(R), Jaipur informed that the work is under Hon'ble CM's budget announcement for FY 2016-17 and adequate budget is available for execution of the work and also reiterated that the lowest offer is workable and justified. CE(R) also confirmed fulfilment of provisions of RTPP Rules, 2013 in the bidding process. After deliberations, it was decided to approve the lowest offer M/S B&G Construction Co., Jodhpur for Rs 11,42,24,824.00 as recommended by CE(R), subject to following:-

- The components of execution part and O&M part in the approved cost shall be adjusted by keeping minimum cost of O&M as per terms & conditions of the tender documents.
- Availability of budget for execution of work during CFY and subsequent years of execution shall be ensured.
- III. CE(R), Jaipur shall ensure that clearances from all the agencies and land acquisition are obtained well in time, so as to avoid any hindrance during execution of the work.

Agenda item no. 31: Price bid for the work of **UWSS** Reorg. of Jodhpur: Takhat Sagar based water supply works viz. improvement of new intake, RW Pump House, RW Pipelines, WTP, CWR & related work (the facilities) on SPR turn job contract including necessary design, build and O&M for 10 years.

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(P), PHED, Jodhpur. During presentation, it was informed that 4 tenders were received for the work and 2 were qualified for opening of price bids and the offer of M/S Geo Miller and Co. Pvt. Ltd., New Delhi for Rs 48,27,000,00.00 is lower than the BOQ amount. They also informed that though the lowest offer is lower than the estimated cost, however, the same is workable as M/s Geo Miller is experienced firm in WTP construction. They also informed that though the lowest offer is lower than the estimated cost, however, the same is workable and likely expenditure of all packages under Phase-I (14 nos.) and Phase-II (8 nos.) shall be within A&F amount of Rs. 740.50 Crs.. In view of above, he recommended for approval of the lowest bid. The agenda item was deliberated in detail. In view to synchronise O&M of both the phases under a single contract, the Finance Committee in its meeting 693 dated 05.01.2016 permitted to finish the O&M work of both the phases simultaneously i.e up to 30.11.2016. It was further informed that after deciding the modality of O&M contract, tender for this work was floated which is under scrutiny. ACE, PHED, Ajmer has further informed that provisional time extension for this work has already been extended upto 31.12.2016. The agenda item was deliberated in detail. During deliberations, CE(HQ) informed that as per clause 2.1.1 of Special Conditions Part-B of the contract there is provision for further extension of O&M period up to 5 years on terms as acceptable to both parties. Non Agenda item no.1:
Action under clase-3 of controt agreement towards works related to clear water gravity trunk main from Pokaran to Santra Bhakhri under Package SPR-2A of PFBS Project

The non agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE (P), PHED, Jodhpur. During presentation, following were informed by the CE (P), PHED, Jodhpur:

- (i) The works related to clear water gravity trunk main from Pokaran to Santra Bhakhri under Package SPR-2A of PFBS Project was awarded to M/S SPML Infra. Ltd., Gurgaon for Rs 230.98 Crs. (Capital work: Rs 226.36 Crs. and O&M: Rs 4.62 Crs.) with stipulated date of commencement and completion as 20.09.2012 and 19.03.2015 respectively.
- (ii) The execution of the work was on slow pace even from the commencement of the work and even after repeated efforts by the department, the contractor could not achieve the stipulated progress in any of the time span as stipulated in Clause-2 of GCC. The financial progress achieved up to stipulated date of completion and till date is only about 43.53% and 62.7 % respectively of total ordered cost for capital works.
- (iii) The adequate budget was available for execution of the work but the contractor did not make progress even to utilize the same.
- (iv) Sufficient sites and approvals were made available to the contractor to achieve the stipulated financial progress as per mile stones prescribed in clause-2 of GCC but the actual progress had been far below the same.



- (v) Large no. of notices / letter were issued by the department to the contractor for improving the progress but the contractor failed to show the desired progress.
- (vi) The work of this package has been stopped in all spheres since Sept., 2016 and the office premise at Balotra has been shut down and there is no deployment of any machine/labour/supervisory staff at any site of the project.

In view of above, CE, Jodhpur requested for action against the Contractor under clause 3 of General Conditions of Contract i.e. rescinding the contract and to execute the remaining work on risk & cost of the Contractor. The agenda item was deliberated in detail. After deliberations, following were decided as recommended by CE(P), PHED, Jodhpur in the agenda note:-

- i. To authorise CE(P), PHED, Jodhpur for action under clause 3 of General Conditions of Contract i.e. rescinding the contract and other actions as per provisions of Cl.-3. However, it shall be ensured that all actions as per provisions of contract agreement and PWF&AR have been taken before rescinding the contract. If required, legal opinion may also be taken.
- To re-invite the tender for execution of unexecuted part of the contract on risk & cost of M/s SPML Infra. Ltd., Gurgaon.

To increase financial limit for the work of TOW by tankers in the outer areas under PHED City Dn-IV (North), Jaipur
