**Subject:-** Diversion of 1.8272 ha. of Forest Land in favour of H.P.P.W.D. for the Construction of Link road Chowk to Sandoa via Dharjol Ropari Dhar Kms. 0/00 to 4/810, within the jurisdiction of Suket, Forest Division, Distt. Mandi (H.P.) (Proposal, No. (FP/HP/Road/40734/2019).

Please refer to the Regional Officer Shimla office letter dated 21.06.2022 cited above on the captioned subject vide which some observations have been raised on the proposal submitted for the approval of Ministry of Environment and Forest. The point wise reply of attended observations is as under:-


1. In reply to point No. 1, it is submitted that the left out unsigned document pointed under EDS Letter dated 28.09.2021 i.e. line plan has now been uploaded as well as attached duly authenticated by the competent authority.
2. In reply to point No. 2 the justification/ clarification on the following points is as under:-
  - i). This point pertains to Forest Department.
  - ii). This point also pertains to Forest Department.
  - iii). The documentary evidence / proof of the desired NOC/ Affidavit has already been forwarded in original to your office through this office letter of even file No. 24621-23 dated 18.12.2021 and uploaded as Additional information on online Part-I at Sr. No. 10.
3. Proceedings of meeting of District Level Committee, Committee, Sub Divisional Level Committee and a copy of records of all consultation and meetings of FRC and Gram Sabha of concerned villages have now been uploaded as well attached herewith for ready reference please.

4. This point pertains to Forest Department.
5. The copy of revenue records viz- Jamabandi for the area proposed for diversion under forest and non forest land are attached herewith for ready reference.
6. 0.9049 ha. non forest / private land area has also been included for which the copies of sale deed/ gift deeds / affidavits made in favour of HPPWD by the private land owners are attached herewith.
7. The dumping site in the proposal have been provided in the private lands for which the affidavits received from the land owners have been attached in the Proposal Folders.
8. To protect soil erosion and moisture conservation by the department has proposed retaining walls and wire crate walls and for cross drainage, the various RCC pipe culvert have been proposed for the smooth flow of water. The above described provisions will lead to no ecological damage and will minimize the possibility of soil erosion.
9. This point pertains to the Forest department.
10. In reply to this point it is submitted that the letters dated 09.06.2022 and 31.08.2022 mentioned in the letter under reference have been added inadvertently by the Nodal office which needs to be reconsidered/ clarified and the question of intimation of road under violation does no arise at all as it has never been intimated by the Public works department if there is any confusion in road or name of road that can be similar in the different / Districts/ areas.
11. In reply No. 11, it is submitted that the line plan has now been uploaded as well as attached duly authenticated by the competent authority.
