With We, M/s Reliance Jio Infocomm Limited has furnished forest clearance proposal for diversion of forest area for laying of underground Optical Fibre Cable along Coimbatore Goundampalayam to Udagamandalam route road through forest areas of Coimbatore Forest Division under proposal No. FP/TN/Others/29282/2017 and based on the inputs obtained from the local Forest staff diversion of 0.90 ha of forest areas in Thadagam RF, Gobinari RF. Nilgiris Eastern Slopes RF and Melur Slope Reserved Forest area of 30.00 km length with 0.30m trench width has been proposed for laying of under ground Optical Fibre Cable connectivity between Coimbatore and Nilgiris District areas through Coimbatore Goundampalalyam to Udagamandalam route road passing through the forest areas.

However, as per the field inspection carried out by the District Forest Officer, Coimbatore Division, length of the underground Optical Fibre Cable in the forest areas lies to a distance of 27.50 km only with 0.30m width of the trench, thus the extent of forest area diversion has been recommended for 0.825 ha under Part-II of Form-A.

Based on the information received from the Principal Chief Conservator of Forests (Head of Department) Chennai and District Forest Officer, Coimbatore Division, attempts have been made in the forest clearance proposal in the web portal.

However, there is no provision available in this forest clearance proposal to modify the parameters of total area required for the project-Forest and Non-forest area Under A-1 of Part-I of Form-A and the proposal area modifications under B-2 and C Section of Part-I could not be made due to area mismatch for extent of area proposed earlier and area now to be modified based on field data verification. For the forest clearance proposal furnished during 2019, area modification facility in the web portal is available. Screen shot of this section for the present proposal (without the parameter of area change designed by MoEF&CC web design) and proposal uploaded during the year 2019 (with the parameter of area change allowed in web design of MoEF&CC) is furnished for kind perusal.

For modification of this section., technical help has also been sought for from the MoEF&CC through e-mail letters dated 09.11.2010 and 10.11.2020 sent @ official email id of monitoring-fc@nic.in. However, there is no response from the MoEF&CC for offering technical help. Copies of the Email sent to the MoEF&CC is enclosed herewith.



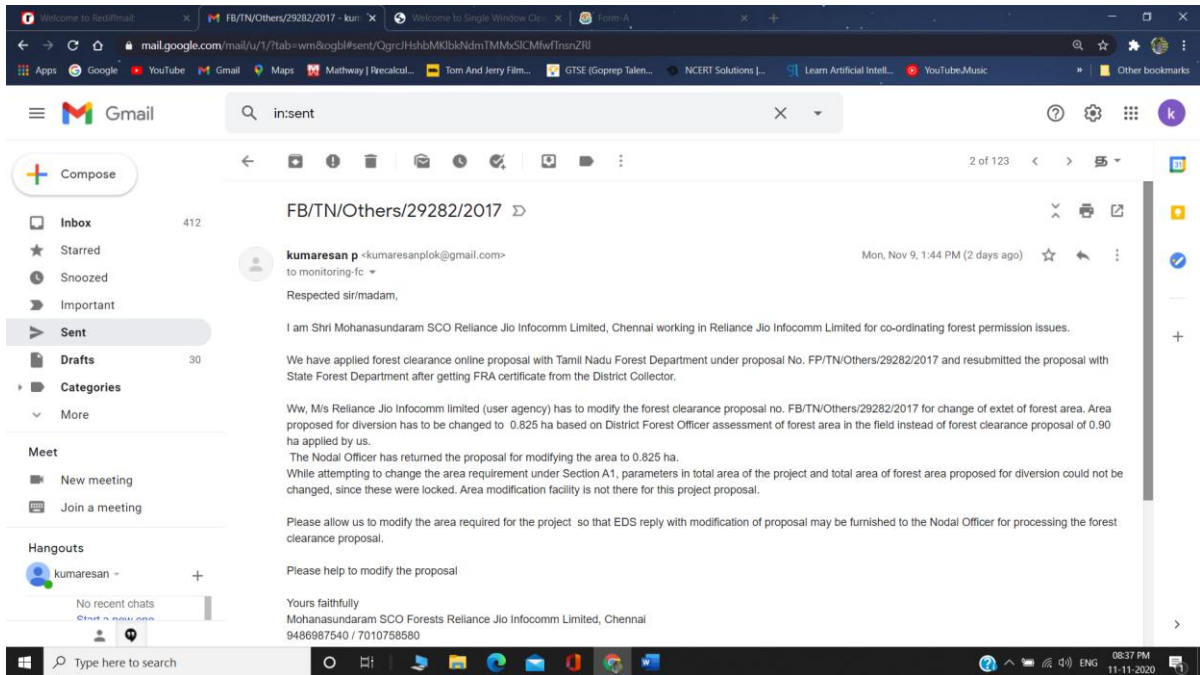
