2. Applicant construct the water harvesting system and meter Spen Slab type coverlet at his own expenses.
3. Applicant will not make any parking up of the road vehicles are parked in marriage palace.
4. Appplicant will not disobey the PUDA rules under act /IRC if applicant disobeys then NOC will be cancelled.
5. Palace water and waste of palace will not on road.
6. Applicant is liable to renew the NOC after 5 years with Government rules time to time. Instead of that any changes in fee then applicant will be liable to pay.
7. Present or in future if road improvement/winding need for construction then if the applicant construct the road area then he will damage it at his won expenses and will not claim for it.
8. Applicant get the permission/NOC from forest department, PUDA department, fire safety department at his own level.

Note Instead of said if any changes in terms and conditions applicant liable to abide ittime to time. If applicant will not follow the terms then NOC will be cancelled without giving any notice.
