With reference to our letter 4th cited above, it is informed that the common boundary of the proposed forest areas of Mannur reserve forest, Sengundram forest and Thirutheri reserve forest and the remaining areas of Mannur RF, Sengundram RF and Thirutheri RF have been demarcated by erecting cement concrete pillars. The demarcation works has been completed on 31.10.2020 in the presence of the forest officials of Sriperumpudur forest range and Chengalpattu forest range.

Hence, it is requested that necessary permission for in- principle approval (Stage-I) may please be got approved from the Ministry of Environment & Forests, Government of India under Section-2 of Forest (Conservation) Act, 1980 for diversion of forest land in Mannur RF, Sengundram RF and Thirutheri RF to Highways Department for formation of Chennai Peripheral Ring Road.
