

In this context, it is submitted that this office has no objection to transfer of land in favour of The Executive Officer, MC Rohru, District Shimla, H.P. subject to the following conditions:-

- 1. Facility shall be designed and setup as per the technical guidelines issued by Central Pollution Control Board from time to time and as per the manual of Solid Waste Management prepared by Ministry of Urban Development.
- 2. The unit shall take prior consent to establish of the State Board under the provisions of Water Act, 1974 and Air Act, 1981 before carrying out any construction activity on Ground
- 3. The landfill site shall be at least 100 meter away from river, 200 meter away from a pond, 200 meter away from highway/hospital/public parks & water supply wells.
- 4. Unit shall take prior approval from all the competent authorities, if any change in land use is required.
- 5. Unit shall comply with the provisions of Solid Waste Rules, 2016 and Construction & Demolition Rules, 2016.
- 6. Unit shall obtain prior environmental clearance from the concerned authority, if applicable.
