the frontage of 30 Mtr. as per recommendation
of I.R.C.-12-1983. This should be provided as

of retail outlet.
2. The buffer strip may also be provided at site
as per I.R.C-12-1983 i.e. 12 x 3 Mtr. against
7 x 3 Mtr. as shown on the detailed drawings,
at the time of installation of retail outlet.
3. The owner at the time of installing of the
retail outlet is required to ensure that the
demarcation of land is taken at site to avoid
encroachment on P.W.D. land.
4. The recommendations of I.R.C-12-1983 with
latest amendments be strictly followed.
5. The permission for access to the retail outlet
be also sought at the appropriate time by the
owner.
