

**SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

5-1: A Proposal has been received by this office from अधिशासी अभियन्ता, उत्तराखण्ड पेयजल संसाधन विकास एवं निर्माण निगम, घनसाली for diversion under (FCA-1980) of 0.359 ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of ई0ए0पी0 के अन्तर्गत टिहरी गढ़वाल के विकास खण्ड भिलंगना में नगर पंचायत चमियाला पम्पिंग पेयजल योजना का निर्माण कार्य। The site inspection of the land involved in the proposal has done by me on date-17/11/2019.
