



**PROCEEDING OF THE MEETING OF THE DISTRICT LEVEL COMMITTEE  
CONSTITUTED UNDER SCHEDULE TRIBES & OTHER TRADITIONAL FORES  
DWELLERS (RECOGNITION OF RIGHTS) ACT (FRA) 2006**

A meeting of the district level committee Tehri Garhwal district constituted under FRA 2006 was held under the chairmanship of **Dr. V Shanmugam**, I.A.S. District collector Tehri Garhwal at New Tehri in which the applicant claiming rights in Jaunpur Block area measuring **12.222 Hectare** for the construction of **Kyari-Masras Motor Road** in Tehsil Dhanolti of forest land under FRA 2006 of the following application duly processed and recommended by the sub Division were discussed to consider the same for admission by the District Level Committee.

After scrutiny of the documents and detailed discussions no objection/claims were found to have been made and hence District Level Committee recommended the above case for diversion for the said purpose.





In compliance of the Ministry of Environment and Forests (MOEF), Government of India's letter No. 11-9/98-FG (pt) dated 3 August 2009 wherein the MOEF issued guidelines on submission of evidences for having initialed and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006(FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MOEF's letter dated 5 February 2013 wherein MOEF issued certain relaxation in respect of linear projects, it is certified that **12.222** hectares of Civil forest land proposed to be diverted in favor of E.E. Try. Divi P.W.D Thatyur for **Aglad-Thatyur Motor Road km 30 to Kyari to Masras Motor Road Scheme** (purpose for diversion of forest land) in Tehri Garhwal district falls within jurisdiction of **Kyari, Bichu, Masras** village (s) in Dhanolti/Nenbag Tehsils.
