

AND

 THE GOVERNMENT OF KARNATAKA, represented by Executive Engineer, Karnataka Neeravari Nigam Limited (KNNL) No.1 T.R Division, Munirabad Village, Koppal Taluk and Koppal District hereinafter referred to as "The Government/KNNL" on the OTHER part.

WHEREAS, the Party of the First Part and the Party of the Second Part approached the Govt. of Karnataka seeking permission to draw water from Tungabhadra Reservoir for their pellet plant and steel plant located at Halavarthi Village Koppal Taluk and District.

Whereas the Government of Karnataka by a common order No: Ja: sum :E 24 MTB 2014 dated 09.11.2015 & Order No: Ja: sum: E 04 MTB 2014 dated 04.02.2020 accorded its approval to the Parties of the First Part and Second Part to draw water 2.55 MGD and 10.00 MGD respectively (total 12.55 MGD) for their plants from Tungabhadra Reservoir.

I. MAIN CONDITIONS:

- This Agreement is executed as per the terms & conditions of (i) the Order of Government of Karnataka, JA: sum: E 24 MTB 2014 dated 09.11.2015 & Order No: JA: sum: E 04 MTB 2014 dated 04.02.2020 for drawl of water by the First Party and Second party from the Tungabhadra reservoir.
- 2. The total quantity of water to be drawn from Tungabhadra Reservoir by (a) M/s MSPL Limited will be 2.55 MGD for its pellet plant and (b) M/s AISL will be 10.00 MGDfor its steel plant; as approved by The Government of Karnataka.

- 3. The Company is allowed to draw water up to RL +1575 feet. When the water level goes below +1575 feet, the Company will not be allowed to draw water and has to make its own arrangements to meet such exigencies.
- 4. The Companies are permitted to construct jack-well, pump-house & allied constructions required to draw water with only intake pipe into the reservoir water body and lay pipelines up to factory as per the approved drawings of the same. The facility so constructed shall be utilized by both the Companies.
- 5. The prevailing royalty charges towards the quality of water so drawn shall be paid to the Executive Engineer, KNNL, TR.Division. Munirabad.
- 6. The agreement shall be in force for 5 (Five) years from the date of agreement 1.e.from 15/7/2000to14/7/2005 and if desired, application for renewal shall be submitted one month prior to the lapse of agreement as per government of Karnataka by a common order No: Ja: sum: E 24 MTB 2014 dated 09.11.2015 & Order No: Ja: sum: E 04 MTB 2014 dated 04.02.2020.

II GENERAL CONDITIONS:

- 1. The Officers of the Karnataka Water Resources Department/ KNNL in this respect shall have access at all the reasonable times, to intake structure / permanent jack-well, pump house and pipeline corridor to verify the records and to check the rate of pumping and the calibrations of the instruments.
- 2. The Company shall intimate the quantity of water drawn to the Assistant Executive Engineer, KNNL, Munirabad on pumping days, with a copy to the Executive Engineer, KNNL, T R Division, Munirabad.
- 3. The company shall construct Rain Water harvesting (RWH) Pond to accumulate and store the rainwater. The water available from the tube wells shall be taken into consideration first and the balance quantity of water should be drawn from TB Reservoir.
- 4. The list of duty staff of the Company, authorized for Operation & Maintenance of the water supply scheme shall be registered with the KNNL.
- 5. The Company should ensure that there should not be any hindrance for drinking water schemes and downstream-irrigated lands of the TB Reservoir.
- 6. The Companies shall not be entitled for any damages either on the ground that the Company has not taken maximum quantity of water herein mentioned above or on the ground that the Company has not been able to take maximum quantity of water owning to deficiency of water in the reservoir.

- 7. KNNL / Government or any designated Officer may prevent usage of water by the Company. In such situations, the Government / KNNL shall not be held liable for any losses caused due to such stoppage of water and will not reimburse for the losses.
- 8. The Company shall fix the water meter, to measure the quantity of water drawn and utilized. In case of any repair or replacement of water meter is required, then it has to be brought to the knowledge of the concerned Officer and should take up the work at their cost.
- The company shall allow any of the concerned officers of Govt. / KNNL to inspect the installation of water meter and gauge.
- 10. From time to time, Govt./ Govt. nominated Officers may inform the Company to recalibrate or validate any mechanical or electrical measurement devices installed by the Company. In such circumstances, the Company should examine the same by a recognized or licensed institute, at their cost.
- 11. The water drawn (utilize) shall be taxed based on Companies Gross Water Quantity that is measured near drawl point. In case there is a loss of water during the transportation from Reservoir to the plant, the Govt. / KNNL or designated Officer will not be held responsible for loss caused during such transportation.
- 12. Company should take utmost care that properties of KNNL and private properties shall not be damaged during construction and operational period. In case of any damage, Company should pay the cost towards losses so caused.
- 13. The Company shall obtain consent from different Departments, as the pipe line passes through lands belonging to different Departments. The Company can lay the pipelines for taking water from the Reservoir, once they obtain the consent from each Department.
- 14. The Company shall take land & other facilities required for company's work either from Government or from private parties, by paying the fixed amount.
- 15. The Company shall carry out any operations only in the occupied landsand it shall not use any of the government or private land withoutauthorisation.
- 16. The Company has to pay the monthly water bills within the prescribed time, to Government / KNNL, as per the rate fixed from time to time.

17. The Company has to pay Rs. 12,000/- per annum as honorarium to Water Resources Department / KNNL.

- 18. Company while discharging water to valley / reservoir after their use has to treat as per the Standards (CPHEEO/BIS/KSPCB) specified by the Government. If the Company fails to do so, the Government may withdrawthe permission so granted, without giving prior intimation.
- 19. Any dispute arises during the implementation of project the company has to settle such dispute. In case, the Government / KNNL incur any expenses to settle disputes, then the Company has to reimburse the same
- 20..The Company has to take prior permission from Forest, Environment and Wildlife department and any other concerned department then to carry out the work in proposed unit.
- 21. In case of any loss or damage caused to Forest, Environment, wildlifeetc, the Company shall be subject to legal proceedings and also liable to payfine as fixed by the Government / KNNL or its designated officers.
- 22. The Company has to pay service tax and all other taxes to Water Resources Department / KNNL and other Departments from time to time without fail.
- 23. If there is any violation of any of the above conditions, Govt / KNNL may revoke the permission granted to the Company without prior notice.
