

Coronet Canning Company, Malpe. The period of lease was 50 years which has expired. The Coronet Canning Company, Madhwaraj Road, Malpe has requested through online application in FC clearance monitoring system for renewal of 0.4858 ha. Forest land for above purpose for further period of 30 years.</p> <p>The proposed area is having casurina, and rain trees likely to be felled, therefore in lieu of these ten times number of plants are proposed for planting and the cost of which is to be recovered from the user agency.</p> <p>The proposal for renewal of lease of forest land further 30 years may be considered on recovery of Net Present Value and by imposing usual conditions as requested by User Agency as lease period already expired.</p>
