The Coronet Canning Company,Malpe Madhwaraj Road, Malpe, Udupi district,Karnataka has submitted through online application in FC clearance monitoring system for renewal of lease of 0.4858 ha. forest land for further period of 30 years as 50 years lease period has already expired on 03-01-2018.

The link received through online FC clearance monitoring system for submitting the proposal through online and hard copy submitted by the User Agency.

The hard copy of the proposal submitted by the User Agency to this office is enclosed, The Govt. Order cited at reference (1) letters an area of 0.4858 ha. of forest land in Fsy.No:108A1 Kodibag village was granted to M/s. Coronet Canning Company, Malpe for installation of fish canning factory.


The User Agency has given under taking to bear the Net Present Value of the proposed forest land for renewal of lease. The under taking is enclosed to the proposal. The above area for renewal of lease has been inspected by me on 10-11-2018 along with Range Forest Officer, Karwar and necessary site inspection report is enclosed. As requested by the User Agency of its utility it is fit for considering for renewal of further period on recovery of Net Present Value

and by imposing usual conditions. User Agency has paid lease rent in lease period.

The proposed area is having casurina, and rain trees likely to be felled, therefour in lieu of these ten times number of plants are proposed for planting and the cost of which is to be recovered from the user agency.

In view of the above it is recommended to move the renewal proposal to the higher authorities for grant of renewal of lease period for further 30 years as requested by User Agency in favour of Coronet Canning Company, Malpe as the lease period of 50 years has already expired. The proposal submitted in 7 sets for perusal and taking needful action in the matter.
