2. In the proposal it has been mentioned that the above Camps sites are at about 60 Km trek distance from the Institute and land belongs to Forest Department. The land at the sites is being used to conduct training with the help of civil administration and forest department. On the advice of the Forest Department the proposal of transfer of land has been initiated by the Principal of the Institute. After discussing the matter with Divisional Forest Officer, Uttarkashi, a joint survey of the land has also been done.
