## Scope of Work -

## · Bill of material & Cost of line items of the Contract -

The Contract Value for 8 years is INR 3,056,69,43,538/- (Indian Rupees Three Thousand Fifty Six Crores Sixty Nine Lakhs Forty Three Thousand Five Hundred and Thirty Eigth only), including all taxes and GST value of Rs. 466,22,95,896/-. The Contract Value includes Total Capex Value of INR 1,975,99,99,180/- (including GST value of Rs. 301,37,78,960/-) and Total Opex Value of INR 1,080,69,44,357/- (including GST value of Rs. 164,85,16,936/-) for Seven (7) years. The quoted unit price Line item wise cost is enclosed at Annexure 'A' with this NoA.

The Contract Value is inclusive all taxes and GST and is as per the financial bid submitted by M/s. Tata Projects Ltd. GST shall be paid on actual at the time of raising the invoice as per the terms and conditions mentioned in the RFP document along with the corrigenda released.

The actual cost will be calculated based on the unit cost enclosed at Annexure 'A'.

## Payment Terms -

Payment terms shall be in accordance with the provisions of the RFP document along with the corrigenda released.

## Acceptance of NoA -

Kindly convey the acceptance of the NoA within 7 (Seven) days from the date of issuance of this NoA.

In accordance with RFP terms and conditions, section 4.38, **M/s. Tata Projects Ltd.** is directed to submit '*Implementation - Performance Bank Guarantee (PBG)*' of 10% of the Capex value (including GST) i.e. Rs. 197,59,99,918/- of the contract value valid upto 60 days after "project Go-Live" in the form specified in the tender document within 15 (*Fifteen) days* from the date of issuance of this NoA.

The other terms & conditions shall be in accordance with the provisions of the RFP document along with the corrigenda released for Selection of Master System Integrator for BharatNet Phase-II Project in the State of Chhattisgarh.

\* Signing of Master Service Agreement / Contract -

On submission of the *Implementation - Performance Bank Guarantee (PBG)* as mentioned above to CHiPS, M/s Tata Projects Ltd. is required to sign a Master Service Agreement through its authorized signatory within 7 (*Seven*) days of receipt of the pro-forma for Contract.

## **Project Implementation** -

After acceptance of NoA and Master Service Agreement signing, **M/s. Tata Projects Ltd.** will conduct and submit site survey for list of GP's enclosed at Annexure 'B' with this NoA. Based on the approval of Site Survey report, Bill of Quantity (BoQ) and Bill of Material (BoM) by CHiPS, M/s. Tata Projects Ltd. shall implement the project.

The project shall be governed in accordance with provisions in the tender document read along with the corrigenda released for Selection of Master System Integrator for BharatNet Phase-II Project in the State of Chhattisgarh. M/s. Tata Projects Ltd. needs to comply with the Implementation plan given in the said tender.
