1. PROJECT DETAILS:-

i. Short narrative of the Proposal and Project /Scheme for which the forest land is required.

The Mahanadi Coalfields Limited (MCL) is a subsidiary company of Coal India Limited a Public Sector Unit owned by Government of India . It is engaged for coal mining in the State of Odisha . The activities of MCL are spread over Angul, Jharsuguda and Sundergarh districts. Total sanctioned Coal Mining Projects till date in MCL are 53 (including 3 exhausted Projects). The rated Production Capacity of these sanctioned Projects was 285.61 Mty, with a sanctioned Capital outlay of Rs.31734.03 Crs (including RCE). Out of total 53 Projects, 39 Projects are completed Projects and 14 are On-going Projects. These 14 on-going projects have rated capacity of 201.83 Mty with capital investment of Rs. 27463.11 Crs.

The Subhadra Project is an Opencast mine combining Utkal-A and West of Gopalprasad (West) coal block and located in Talcher and Chhendipada Tahasil of Angul District of Odisha State. The total requirement of land for the Project is 1111.85 Ha, of which 0.75 Ha is Reserve Forest land, 47.59 Ha is Revenue Forest Land and 76.90 Ha is DLC forest land (totaling 125.24Ha). The balance land is non forest land. Hence the present application is for diversion of 125.24Ha of forest land.

Total extractable coal reserve of this project is about 768.83 million tonnes including 80.36 Million Tonnes in forest land . The peak capacity of the project is 25 Million tones per year. There are total no. of 20 seams including splits with the thickness of coal seams ranging from 0.13m to 35.26 m and located at a depth between 23.00 m to

For the purpose of compensatory afforestation, 110.64Ha Govt. Non-Forest land and 40.255Ha (double the degraded revenue forest land) total 150.895Ha has been identified and finalized in respect of proposal seeking prior approval of Central Government under Sec.2 of Forest (Conservation) Act, 1980 for approving the diversion of 125.24Ha. forest land situated within the project area.

The DGPS survey of the above area 150.895Ha has been completed along with authentication of DGPS map from ORSAC, Bhubaneswar on 26.08.2022.

Regarding Safety Zone, it is to state that the area along the forest area proposed for diversion is coming out to be 1.47 Ha. Subhadra OCP, Subhadra Area, MCL agrees to pay the cost for protection and regeneration of safety zone area and also for cost of raising plantation to the tune of 1.5 times of the safety zone area in 2.20 Ha, in degraded forest land.

Utkal-A coal Mine(Utkal-A & West of Gopal Prasad West coal blocks in the Talcher coalfields, Odisha) to be worked through Subhadra OCP (25MTY) has been allocated by MoC under Coal Mines Special Provisions Act-2015. The project comes under the administrative control of MCL, Sambalpur. The proposed project is a new one.

The villages falling in core zone are Bhalugadia, Kankarei, Raijharan, Golagadia, Baghuabol, Balichandrapur, Kumunda, Chhotabereni, Pirakhaman and Kaunsidhipa. Near about 2018 families will be affected due to this project. Total population of the core zone is 7821. No. of Males is 3987 and Females is 3834. Total SC population is 1969 and ST Population is 760. These families will be resettled and rehabilitated socially, culturally and economically along with other displaced members such as major married sons, unmarried daughters of upto 35 years of age as per existing R&R policy-2006 of Govt. of Odisha.
