Sub: Application for granting permission for laying natural gas pipeline across Forest Land in Jind District of CGD project coming under your jurisdiction.

Dear Sir,

Hindustan Petroleum Corporation Limited (HPCL), a Government of India Enterprise, proposes to lay a grid of Gas Pipeline for transportation of natural gas from City Gate Station to various CNG stations and other consumers like PNG (D), PNG Commercial, PNG Industrial for city gas distribution in the Geographical Area (GA) of Sonipat - Jind (Haryana) based on PNGRB authorization.

In the 9th round of bidding conducted by Petroleum and Natural Gas Regulatory Board (PNGRB) for CGD network. HPCL emerged as successful bidder in Sonipat (except area already authorized) and Jind Districts (Sonipat-Jind GA). PNGRB vide letter dated 26.09.2018 has authorized HPCL to lay, Build and Operate CGD network in Jind - Sonipat GA (Haryana).

The proposed Natural Gas pipeline will along the Jind to Narwana National Highway - 352 coming under Jind District for a length of 45305.06 mtr. It will be worthy to state here that the pipeline will be laid 1.2 mts below the Natural ground level and after laying Pipeline used area shall be restored back. The used area for the diversion of Protected Forest is as shown in the table given below.

The forest lands as identified by us are included in the application. However, if any area is left out, the same may please be included. The necessary drawings for the forest strip are enclosed herewith.

Necessary application, along with Proposal in five copies is submitted herewith for perusal and recommendation to grant permission to lay the pipeline. We are willing to pay compensation as per rules.

This project is of national importance and the progress of the same is being monitored at Ministry level on a regular basis so kindly issue us the demand note for the length so that CNG /PNG be distributed in District- Sonipat & Jind as per PNGRB guild lines though gas pipeline.
