Tamilnadu Transmission Corporation has proposed to establish 765/400KV SS at Virudhunagar and its associated 765KV and 400KV transmission lines in Tirunelveli Region and it was permitted to execute the work vide G.O.(MS) No.35 Energy (A1) Department dt 24.05.2019.

With reference to letter (2) cited above, the reply for the short comings are updated in the online parivesh portal-1 which are mentioned below:

- 1. Form A: Part-I Sl. No. A-1 (ii) & (iii), name of RF changed from Uthappanayakkanur RF to "Uthappanayakkanur Bit-I RF".
- 2. Form A: Part-I SI. No. A-2, No editable option has been available in the portal to change the name of the user agency from Transmission Line Construction (TANTRANSCO) to Tamilnadu Transmission Corporation Ltd (TANTRANSCO). Regarding this, complaint has been raised in parivesh portal-1 to resolve the issue

on 10.10.2024 but it was not rectified till date. So, User agency name was not able to corrected. It may be considered as "Tamilnadu Transmission Corporation Ltd (TANTRANSCO)".

- 3. Form A: Part-I SI. No. B-2.4, Since the area of the forest land is a non linear one, the dimensions are not able to specified and it is updated in the portal.
- 4. Form A: Part-I SI. No. C.(ii), Nature of the Project is changed to Non-linear as per the shape of the area in the map.
- 5. Form A: Part-I SI. No. C.(ii) (b), Since the variation in between the required forest land area in the kml file is 7446 sqm and the TANTRANSCO request area is 7460sqm is a tiny one, which may be considered as per TANTRANSCO request.
- 6. Form A: Part-I SI. No. D (i), Detailed Justification has been updated in the portal.
- 7. Form A: Part-I SI. No. K (i) (a), The name and seal of District Collector's certificate is updated in the portal
- 8. Form A: Part-I, Additional Information section details, area requirement is changed from 0.901 to 0.746 ha of forest land and updated in the portal.
- 9. In additional information section details, name and seal of District Collector's certificate is updated in the portal
