UNDERTAKING

M/s. Jio Digital Fibre Private Limited has applied for diversion of Forest area for laying of underground Optical Fibre Cable along the National Highways/State Highways road.

In Government of India guidelines of Forest (Conservation) Act, 1980 in F.No.5-3/2007-FC, dated 05.02.2009, payment of Net Present Value for underground laying of Optical Fibre Cable has not been allowed, if the area does not fall within a National Park / Sanctuary and no felling of trees is involved.

The above area is not declared as National Park / Sanctuary. Hence Net Present Value is not payable in the present case.
