With reference to Government in Steel & Mines Department memo no.7747/SM dt.7.8.96 I am to inform that State Government have been pleased to order for demarcation of the area over 406 hecta. out of 1261.476 hecta. for grant of 2nd renewal of mining lease in favour of N/s. TISCO in pursuance of Govt. of India order no.5(22)95-MIV dt.17.8.95 and orders of Hon'ble Supreme Court of India dt.22.7.96. A copy of the map showing the above 406 hecta. area is enclosed herewith for reference.

The Deputy Director of Mines, J.K.Road has been instructed to demarcate the above area over 406 hecta. in the field within a weeks time.

You are therefore requested to render necessary assistance in demarcating the said area and handover possession of the balance area over 855.476 hecta. to D.D.M., J.K.Road. You are also requested to stop all mining operations beyond the area over 406 hecta. proposed to be granted under 2nd renewal of mining lease for 6 months.

Sub: Grant of 2nd Renewal of Mining Lease for Chromite in the district of Jajpur.

Re: Application presented on 3.10.91 by m/s. TISCO Ltd. for grant of 2nd Renewal of Mining Lease for Chromite over an area of 406.00 hecta. in village Kalarangiatta, Ransol etc. in the district of Jajpur.

Order:

Whereas m/s. TISCO Ltd. have applied to the State Government for grant of a 2nd Renewal of Mining Lease for Chromite by their application read above;

Whereas the mineral in the land in respect of which the 2nd Renewal of Mining Lease has been applied for belongs to Govt. and the land is at their disposal;

Whereas the applicant being a limited company is incorporated or registered in India;

Whereas the applicant by themselves with or with any person joint in interest with them do not in respect of Chromite or related group of minerals held such area in the state as with the area over which the Renewal of Mining Lease has now been asked for will not exceed twenty five square kilometres in the aggregate;

Whereas the Govt. of India in their letter No. 5(22)/95-M.IV dated 17.8.95 have conveyed their approval to the grant of 2nd Renewal of Mining Lease under section 8(3) of the M.M.(R&D) Act, 1957 read with rule 27(3) of the Mineral Concession Rules, 1960 subject to compliance of the amended provisions of Act & Rules and other applicable Act & Rules including the F.C. Act, 1980;

Whereas the party was asked in this Deptt. letter No. 1295/SM, dated 15.2.97 to accept the terms and conditions under which the renewal of Mining Lease was proposed to be considered for grant and the party in their letter No. FAMD-EIC/3899 dated 5.8.97 accepted those conditions;

Therefore, the State Govt. are hereby pleased to order that a 2nd Renewal of Mining Lease for Chromite in respect of the area over 406.00 hecta. in village Kalarangiatta etc. in Sukinda area in the district of Jajpur be granted to M/s. TISCO Ltd. for a period of 20 years subject to the conditions laid down in the State Govt. letter No. 1295/SM, dated 15.2.97 and 6326/SM, dated 23.7.97. The party should comply with all the terms and conditions including furnishing of a surveyed map and demarcation within 3 months from the date of this order to the Collector, Jajpur.
