## PROCEEDINGS:

- 1. Government of Andhra Pradesh has issued GO. Ms.No. 56, Dt.26.04.2017 for providing necessary infrastructure facilities to M/s KIA Motors Corporation (KMC)Automobile manufacture unit near Erramanchi and Gudipalli (V) in Anatapur district .As per Para no.IV, of above GO ,Govt. of Andhra Pradesh has to provide permanent Electricity of 70MVA from 220 KV Double Circuit transmission lines from 2 feeder sources ,namely Bokasapally Sub Station and Subbarayuinipally Sub Station and also directed the concerned to prepare detailed estimates and seek approval from the competent authorities .
- 2. In this connection, ,for providing power supriy at 220 KV Level to KIO Motors as per the Government Order the following works has to be carried out.
  - i. Erection of 220KV Switching Station (with 4 Nos bays) at M/s. KIA Motors Corporation (KMC) Automobile Manufacturing Unit near Ammavaripalli(v) in Anantapur Krishna District.
  - ii. Erection of 2Nos. 220kV feeder bays at 220/33kV Subbarayunipalli SS & 2Nos. Bays at 220/132/33kV Boksampalli SS
  - iii.Erection of 220KV DC line (13KM)from 220/33kV Subbarayunipalli SS to 220kV Receiving Station at Ammavaripalli
  - iv.Erection of 220KV DC line(23KM) from 220/132/33kV Boksampalli SS to 220kV Receiving Station at Ammavaripalli. Line length considered as 22KM instead of 17KM after conducting walkover survey to avoid forest crossing.
  - v. Erection of 220 KV Terminals & Metering Bay
  - vi. And Necessary Communication facilities.
- After careful consideration, APTRANSCO accords administrative approval for providing power supply at 220 KV Level for a load of 70MVA to M/s KIA Motors Corporation (KMC)Automobile manufacture unit near Erramanchi and Gudipalli (V) in Anatapur district", at an estimated cost of Rs 9983.47 Lakhs as detailed below.
