

1. Mining Plan of the proposed mahal/quarry area.
2. Forest Right Act, 2006 Certificate (FRA-2006).
3. SOI Toposheet Map (1:50,000 scale) showing the Mahal/Quarry area along with GPS coordinate.
4. Geo-reference map and KML file of the proposed mahal/quarry area.
5. Undertaking for payment of Net Present Value & additional NPV in non judicial stamp paper.
6. Undertaking for demarcation and construction of boundary pillars, raising afforestation equivalent to one and half time of safety zone area in non judicial stamp paper.

Further you are requested to obtain a hard copy of the online proposal i.e duly filled up Form-A part (I) along with the aforementioned documents from the provisionally tenderer and to furnish the same to us for onward action


