

- 1 The sanctioned work(s) will preferably be got executed through the concerned department/departmental Technical Manpower available in the District/Pradesh.
 - 2 The work(s) should be executed in accordance with the approved estimate(s) design(s). The Technical officer/Authority who technically approved the estimate(s) will also be competent to assess the work(s) and authorize the disbursement of payments.
 - 3 The expenditure should be restricted the actual amount sanctioned using the relevant financial year.
 - 4 All the payments should be made on regular bills/vouchers duly entered in the measurement Book(s). The work(s) should be completed within the relevant financial year or within one year from date of sanction.
 - 5 The expenditure should be debited in major head of account 8235-General & Reserve head III-Natural Calamities relief account demand No.5 for the year 2006-07.
 - 6 The estimate(s) of the proposed works should not contain the cost of department charges.
 - 7 The UCs/CCs of the sanctioned work(s) should invariably be sent to the DC Office Nahan as per the time-schedule fixed for the completion of the said work(s).
 - 8 The sanctioned funds can however, partly be utilized for the purchase of materials/equipments needed for the works/projects and should be consumable in the process of implementation but no store articles can be purchased under NCR.
- The revision of estimate(s) sanction(s) is not allowed under NCR.
