

**SITE INSPECTION NOTE ON CA (NON FOREST C.A LAND) OVER AN  
EXTENT OF 3.71 HA. IN KAKINADA RANGE OF KAKINADA  
(TERRITORIAL) DIVISION.**

As per the directions issued in hand book of Forest Conservation Act, 1980 guidelines communicated vide GoI, MoEF, New Delhi F.No.5-2/2017-FC, Dt.28-03-2019, and as per the special provisions of the said guidelines, Compensatory Afforestation shall be raised and maintained at the cost of user agency on Compensatory afforestation land in extent the forest land diverted in case of the projects implemented by the Central Government/PSUs and State Sector Projects implemented by the Central Government/PSUs. As per these guidelines, it is mandatory to raise Compensatory Afforestation over an extent of 13.71ha of Compensatory afforestation Land identified in Kakinada Division in lieu of diversion of forest land of 13.28ha (Compartment No.741 of Pujaripakalu RF and Compartment no.263 of Maredumilli RF, Compartment no.333, 334 and 338 of Kota south-I RF and Compartment no.150 of Tadepalli RF Kakinada Division) for formation of road from Vetukuru to Siripuram in favour of Executive Engineer, PR (PIU) Kakinada. I have inspected the above CA area along with concerned staff on 28.11.2021 and submitting my remarks as follows.

The basic aim of the present scheme is to compensate the loss sustained due to the diversion of the forest land and to protect and develop in extent of Compensatory afforestation land into artificial forest with main emphasis on protection of soil from erosion through soil and moisture conservation works.

**CA AREA PROPOSED FOR TRATMENT:** The following forest area is identified for raising Compensatory afforestation, over an extent of 13.71ha. in Kakinada division of East Godavari district as follows:


Mandal of Kakinada Section is under the protection and management.
