Subject: Prior approval of the Government under Section 68(1) of Electricity Act, 2003 for "POWERGRID Works associated with common Transmission System for Phase-II Generation Projects in Odisha" by POWERGRID Corporation of India Ltd. (PGCIL).

Reference: i) PGCIL letter no C/CP/CEA/Section-68 dated 15.06.2015

Sir,

This has reference to PGCIL letter dated 15.06.2015 seeking prior approval of Government under section 68 (1) of the Electricity Act, 2003 for "POWERGRID Works associated with common Transmission System for Phase-II Generation Projects in Odisha" with following scope of works.

- (i) Addition of 2x1500MVA, 765/400 kV ICTs with associated bays at Jharsuguda (Sundargarh)
 - (ii) Addition of 2x1500MVA, 765/400 kV ICTs with associated bays at Angul
 - (iii) Split bus arrangement at 400 kV and 765 kV bus in both Angul and Jharsuguda (Sundargarh) substation (with GIS at Jharsuguda)
 - (iv) LILO of both circuits of Rourkela-Raigarh 400 kV D/C (2nd line) at Jharsuguda (Sundargarh) substation with associated line bays (GIS) at Jharsuguda (Sundargarh) substation
2. The scope of works mentioned at element (i) & (ii) and element (iii) & (iv) above has been agreed in the 1st-2014 / 16th and 17th Standing Committee Meeting on Power System Planning of Eastern Region held on 02-05-2014 and 25.05.2015 respectively at NRPC, New Delhi.
 3. CEA conveys the prior approval of Government under Section 68(1) of Electricity Act, 2003 for the scheme "POWERGRID Works associated with common Transmission System for Phase-II Generation Projects in Odisha" with above scope of works.

4. This approval is subject to compliance of

- (a) The requirement of the relevant provisions of the Electricity Act, 2003, as amended from time to time and the rules and regulations framed there under and
- (b) CEA's (Measures relating to Safety and Electricity Supply) Regulations, 2010 framed under the Electricity Act, 2003.

5. The approval is also subject to the following conditions:

- (i) The implementing agency will commence construction of the project within three years, unless this term is extended by the Central Electricity Authority.
- (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one month notice.
- (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Government of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
