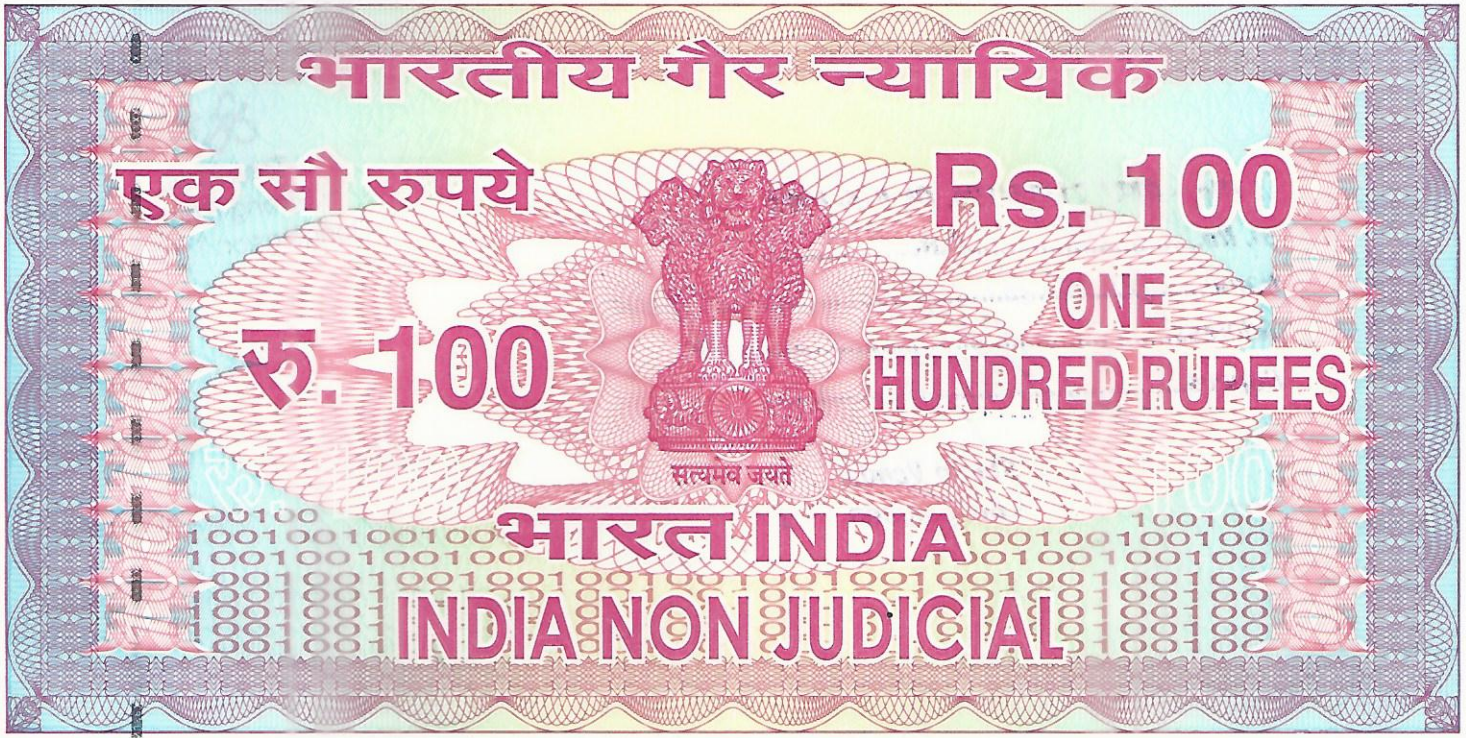

**CERTIFICATE FOR MINIMUM USE OF FOREST LAND**

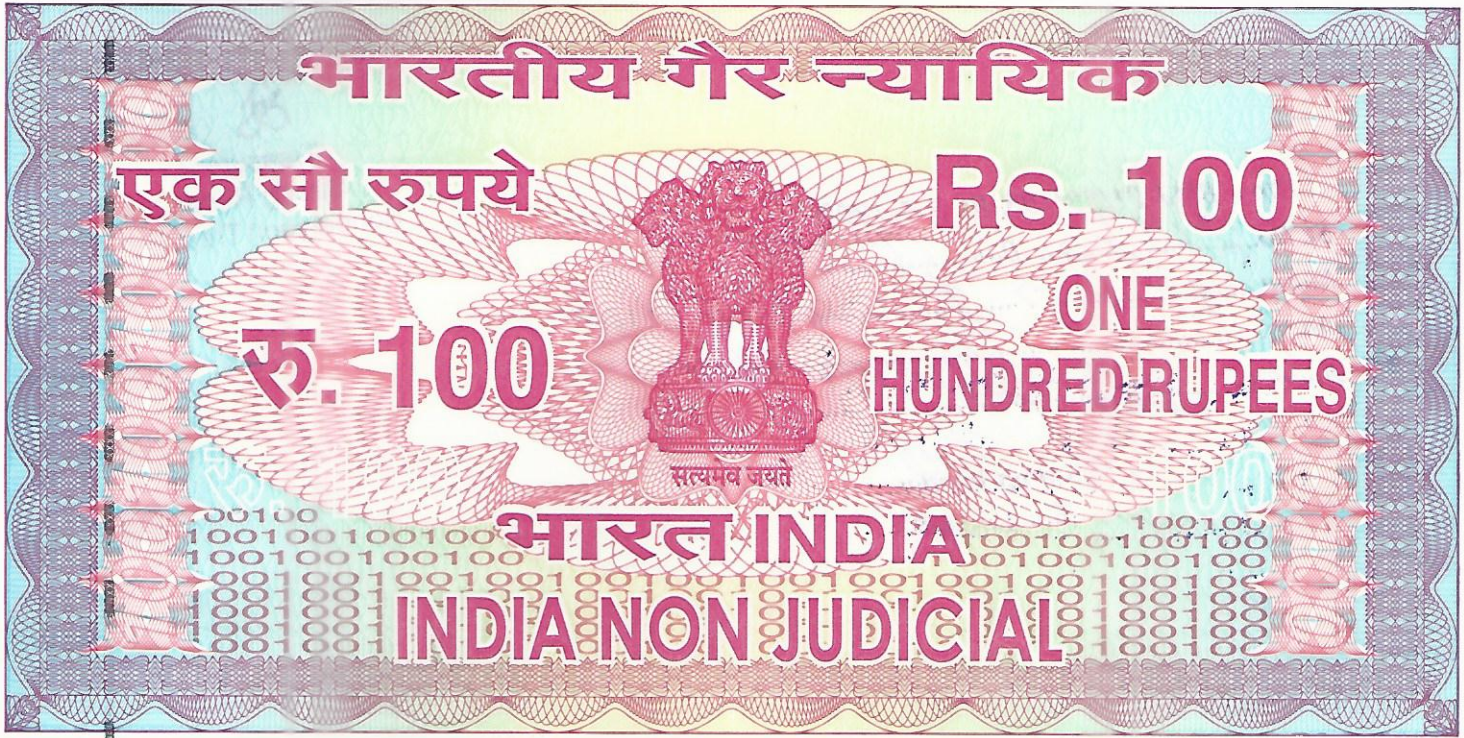
