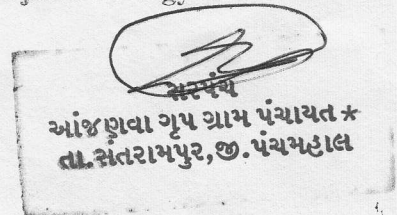

A Gram Sabha is conducted today on 22/09/14 Date Monday day in village Anjanva under the chairman ship of Ramanbhai. Bhurabhai. Solanki Sarpanch Anjanva village more than 90 % ,members of Gram Sabha were present in the meeting and the following issues were discussed in the Gram Sabha meeting.

- (1) In Anjanva Village Gujarat Energy Transmission Corp.Ltd. has applied for diversion of forest land measuring 1.51.92 Ha. For non-forest purpose.
- (2) The aim, objectives and use of the said diversion proposal was discussed thoroughly in the Gram Sabha meeting.
- (3) The Rules and regulations of the Scheduled Tribe and the other traditional Forest dwellers (Recognition of Forest Rights) Act.2006 were discussed keeping in view the said forest diversion proposal. The forest lands proposed for diversion is coming within Erection of 66KV Savdas na Muvada-Rajayata "H" frame line of Gujarat Energy Transmission Corp.Ltd. No Schedule Tribe and other traditional Forest dwellers, are cultivating, residing and doing other traditional activities within the proposed forest land and no Forest Right (individual or community) has been granted to any Scheduled Tribes and other traditional Forest dwellers within the forest land proposed for diversion.

Hence it was unanimously resolved in the Gram Sabha for proposed diversion of 1.51.92 .a. Forest land for non-forest purpose Erection of 66KV Savdas na muvada-Rajayata "H" frame line in favour of Gujarat Energy Transmission Corporation Limited.
