- 1. CA should be taken over degraded forest land 1.5 times in extent of the forest land being diverted for the safety zone. The State Government will submit revised CA plan accordingly.
- 2. The State Government will submit map of the safety zone duly authenticated by the competent authority of the State Government;
- 3. Stipulations made in the Stage-I approval dated 10.05.2013 shall remain applicable in the instant case also.

4. The total area being diverted against this lease now will be 1018.50 ha including 998.07 of forest land for which stage –I approval has already been granted vide letter dated 10.05.2013.

After receipt of the compliance report on fulfillment of the conditions mentioned above, the proposal shall be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980.
