The said proposal was discussed with you in detail during the 35th Meeting of FRC on 08.11.2023 in MoEF Lucknow, wherein, the issue of uploading of KML file of alternate alignments showing the forest areas was raised by your good office. NHAI representatives informed that, they were not able to upload the said KML file on Parivesh Portal and handed over the said file in Pen-Drive to your office. However, to facilitate uploading of the said KML file, EDS -2 was issued by your office on 09.11.2023. In this regard, you are hereby again informed that, the said portal is not supporting / doesn't have provisions for uploading of KML files of alternate routes on Parivesh Portal. Parallely, we have raised Ticket also on 22.11.2023 with ID No. TIC-23000118, which still remains unresolved.

In view of above circumstances and facts & as discussed by PD, PIU-Gorakhpur with DIG, MoEF, this office requests you, once again for according approval of Stage I for the subject proposal for transfer of RF 4.495 Ha. + PF 0.451 Ha. aggregating to 4.946 Ha. of Forest land to NHAI / MoRTH at the earliest.
