Ref: Your Telephonic message Dtd:21-11-05

This is with reference to our telephonic discussions Dtd: 23/11/05.

In this regard it is intimated that in case of M L No 2395 (Old No 1671). A proposal was sent to Govt of India for diversion of 43.30 Ha forest land. (30.33 Ha already broken and 13 Ha unbroken area). Compensatory Afforestation was proposed for 13 Ha in Betasur village in Savadatti Taluk in Block No 636 (Class C & D land).

Govt of India, Ministry of Environment & Forests, New Delhi vide its letter No 8-42/2001-FC Dtd: 20/6/2001 & 3/7/2001 after careful consideration of the proposal on the recommendation of advisory committee to the Govt of India, Ministry of Environment & Forests, New Delhi, has conveyed its approval under Section 2 of F C Act 1980 for renewal of M L No 1671 over an area of 30.33 Ha of Forest land i.e. the forest land already broken up in favour of Ms.Doddannavar Bros. Certain conditions were imposed by Govt of Karnataka and the condition No 10 says that "the lessee shall deposit the amount at prevailing rates towards the raising compensatory afforestation" However through corrigendum issued by Govt of Karnataka No FEE/18/FFM/2001/Bangalore Dtd:7/5/2002 the above mentioned condition (No 10) is deleted.

With reference to the above, I am submitting herewith draft proposal under section-4 Karnataka Forest Act 1963 in respect of sy.no. 636 of Betsur village of Saundatti Taluk in Ghataprabha division. The extent of 22.20 ha. is already been mutated in favour of forest department and R.T.C. is already been issued. It is reported that compensatory afforestation was raised in the area in 20.00 ha. during 2001-02 with the species like Tapasi, Sirsal, Sissoo, Hulgai etc. Shrubby growth of species like Doonea viscoa, Acacia lantronum, Tatropha species, Moringa tinctoria, Caasia species, Anona squamoza, Cantheium dicocum, chloroxylon sweitina etc. were also observed in the area. Area is free from encroachment and there is no hamlet or settlement inside it. The area was inspected by me along with the Deputy Conservator of Forests, Gokak to Examine the possibility whether the scope of notification may be extended to the balance land bank area in this sy. no. as well. But in view of the issue of RTC for 22.2 ha., presently proposal is being submitted for the area already mutated in favour of forest department. However for the sake of clarity the land bank area is also shown on the map in a different

colour along with the actual area demarcated for notification. There is no other forest land in this village.

Further it is clarified by the Deputy Conservator of Forests, Bagalkot that along with 9.2 ha (mining lease no. 465) proposal was also sent to Govt. of India under section 2 of F.C. Act. 1980 for mining lease no. 2395 (old no. 1671) where in for 13 ha of unbroken land, the non forest area was also been identified in the same Sy. no. (sy.no. 636) of Betsur village in saundatti taluk Therefore the proposed area of 22.2 ha covers the two mining leases as stated here. I am submitting here with concerned documents along with maps sketches for your kind perusal and further needful.
