

**NO OBJECTION CERTIFICATE**

The NOC was earlier issued to M/S Hamsu-I Hydel Power Project (0.80MW) village Bulang P.O. Fozal Tehsil & Distt. Kullu vide this office letter No.PW/KD-II/NOC/Steno/2011-4026-27 dated 21.6.2011. Now M/S Hamsu-I Hydel Power has applied for the revised NOC of the enhanced capacity of Hamsu-I Hydel Power Project from 0.80 MW to 2.00 MW. As reported by the Assistant Engineer Katrain Sub Division No-I HPPWD Katrain vide his office letter No. 288 dated 30.5.2015 on inspection of the site of the proposed Hamsu-I Hydel Power Project (2.00 MW) that at present there is no road alignment has been proposed near the site of the above named power project and is 350 meters away from the existing Parari Bridge on the Pichhlihar Neri Kathi Kukari road at Km./RD 0/260. The company wants to construct approach road to their power house from Pichhlihar Neri Kathi Kukari road at RD 0/300 nearby a bridge span 40 meter existing. Hence this Department has No objection for setting up this enhanced capacity of Hydro Power Project (0.80 MW to 2.00 MW) and construction of proposed road subject to the following condition.

- 1 That during the construction of approach road the control blasting may be done to avoid the damage to bridge/ road. If any damage occurred to the road/ bridge at the time of construction the total cost of damages shall be borne by the project authority.
- 2 No damage should be caused to the road surface road furniture such as kilometer stone, sign board, retaining wall/breast wall by way of carriage and stacking of material any damage so caused shall have to be restored to its original position.
- 3 That the company shall not stack any construction material on road side during the construction.
- 4 That there shall be no any type of traffic hindrance during the construction activity by the company.
- 5 That the company may ensure that no debris should be thrown on the PWD land/road.
- 6 That the company may also ensure that no debris should be thrown on the Nallah i.e. up stream of bridge to avoid the any blockage for protecting of damage to abutment etc.
- 7 That in case department proposed to construct any project at that area in later stage the company shall have no objection for the construction of the project.
- 8 That any violation of above may result in cancellation of NOC.
