Sub : Diversion of 1.33 ha. of forest land in near Adkoli Cross in F.Sy. No. 54A of Kansur village in Siddapura Taluk, Uttar Kannada district for establishing 1X10MVA, 110/11kV Substation along with construction of 110 KV LILO line from Jog-Sirsi DC line using Lynx conductor in favour of the Executive Engineer(Ele.), Major Works Division, KPTCL, UK Dist., Vidhyut Nagar, Hubballi. **(Proposal No: FP/KA/Substation/36164/2018)- Submission of compliance report- Reg.**

Anent to above subject, it is to submit that the certain crucial information & clarification required for processing the subject proposal under FC Act vide reference letter No. (9,) are furnished in succeeding paragraphs:-

- (1) Reference Item in Form -A: **B-1. Details of an already submitted proposal with MoEF File No. as A5(2)/GFL/CR-11/12-13 area proposed for diversion as 30 Ha. and with the proposal status 'Returned' are entered. However, there is no such MoEF file number and no. KPTCL proposal for such an extent.**

Initially, the offline proposal of diversion of 30Ha. of forest land for construction of 110kV SC line on DC tower in Bhatkal Taluk, Uttar Kannada district was submitted. Subsequently, FC web portal has been launched & same proposal has been submitted online by creating user agency profile in FC web portal. While submitting the online proposal, it was needed to create online profile in favour of the Executive Engineer(Ele.), Major Works Division, KPTCL,

UK Dist., Vidyut Nagar, Hubballi. In that format , it was required to fill the relevant field i.e. "details of proposal seeking prior approval of Central Government under the Act for diversion of forest land for the project already submitted in the past." Hence, MoEF file No. as 'A5(2)/GFL/CR-11/12-13' has been mentioned in that field. Now same MoEF file No. appears in all new proposals submitted online in favour the Executive Engineer(Ele.),Major Works Division, KPTCL, UK Dist., Vidyut Nagar, Hubballi. It cannot be edited by user agency . Hence, same has been appeared in the subject proposal also.

3. Please clarify whether you have referred your earlier offline proposal No. FP/KA/TRANS/866/2011(converted to online).

The withdrawal of our earlier offline proposal No. FP/KA/TRANS/866/2011 pertaining to diversion of forest land for subject work has been submitted to your kind office vide reference ltr. No. 3, & copy of letter has been uploaded for your kind reference.

K(i). Whether the process for settlement of Rights under the Forest Rights Acts 2006 on the forest land proposed to be diverted has been completed?

The new **RoFR certificate in FORM-II** for 1.33Ha. forest land (for Non-linear/ Hybrid projects) has been obtained from the Deputy Commissioner, Uttar Kannada District & same will be uploaded.

Additional Information Details/ General: 1. Please clarify through a Clarification Note whether the entire project involves only the three given components viz., (i) Sub-Station, (ii) Approach Road and (iii) 110kV LILO line from existing Jog-Sirsi DC line using Lynx conductor for a distance of 0.3km or not and whether any non-forest land is also required for the project.


It is to submit that the construction of (i)110kV Sub-station , (ii) Approach road from existing road to proposed Sub-Station (iii) associated 110kV LILO line involves in the entire project which requires diversion of only 1.33ha. of forest land. Non-forest land is not required for entire project. Clarification Note is uploaded.

2. If any additional components (including Transmission Lines) are also involved in the entire project.

No other additional components are involved in the entire project. Entire alignment of the project in the form of Auto Cad drawing & GPS readings in MS Excel sheet are uploaded.
