With reference to your letter No. cited above, it is to inform you that the points from AP 12 to AP 44 & Gantry, the details status of the area are as given below. It is also to inform you that as per the FC Act, 1980 you may come up with diversion against the area along with complete supporting documents & DPR.

The area details of proposal area according to your map area as follows:-

1.	AP 12/1 (Coordinates N- 27°58' 09.7" E- 95° 43' 53.8" to N- 27° 58' 17.2" E- 95° 43' 52.4") – the area falls under Deopani Reserve Forest.
2.	AP 12/2 to AP 27/0 (Coordinates N- 27°58' 17.2" E- 95° 43' 52.4" to N- 28° 04' 30.4" E- 95° 46' 31.8") – the area falls under De-reserved area (Non- forestry area), Area not falls under USF category.
3.	AP 27/0 to AP 32/4 (Coordinates N- 28°04' 30.4" E- 95° 46' 31.8" to N- 28° 06' 29.8" E- 95° 48' 12.4") – the area falls under De- reserved area (Non- forestry area), Area not falls under USF category.
4.	AP 32/4 to 33/0 (Coordinates N- 28° 06' 29.8" E- 95° 48' 12.4" to N- 28°06' 38.9" E- 95° 48' 18.9") – the area falls under Anchal Reserve Forest, Meka (Protected Forest)
5.	AP 34 /0 (Coordinates N- 28°06' 46.9" E- 95° 48' 19.3") – the area falls under private land
6.	AP 35/0 to AP 41/0 (Coordinates N- 28°06' 53.2" E- 95° 48' 12.1" to N- 28° 09' 24.5" E- 95° 48' 23.4") – the area falls under Deopani Reserve Forest.
7.	AP 41/0 to AP 44/0 (Coordinates N- 28°09' 24.5" E- 95° 48' 23.4" to N- 28° 09' 24.1" E- 95° 49' 59.4") – the area falls under private land.
