The Haryana State Agricultural Marketing Board is pleased to accept your tender as referred above and allot the above subjected work to you on the below mentioned rates and conditions subject to description, terms and conditions as fully explained in the approved DNIT for completing the whole work within (6) month from the date of issue of this allotment letter:-

#### CONDITIONS :-

- If the overall as per actual execution increased than that approved by the competent authority in the present tender case (+) 8.95% above DNIT/ceiling cost/analytical rates then recovery will be effected accordingly so as to bring the overall Excess as per actual execution of work as approved in the tender case.
- 10% (Ten percent) security shall be deducted from your each running bills subject to maximum upto 5% of total amount of work and earnest money shall be adjusted against security.
- Income Tax, GST and Labour Cess plus usual surcharges, if any fixed by the Govt. will be deducted on gross amount of each bill as per Govt. instructions issued from time to time.
- Cement will be arranged by the agency.
- Bitumen will be arranged by the agency.
- Steel will be arranged by the agency.
- The work will be carried out strictly in accordance with the PWD/IRC/MOST specifications with its up to date amendments/corrections to the entire satisfaction of the Engineer-in-Charge of the work.
- The time limit will be reckoned from the date of issue of this allotment letter.
- Rates of N.S. items not quoted by you will be paid as taken in the financial statement or approved by the competent authority which ever is less.
- In case earth is brought from lesser lead than that of specified lead in the DNIT, then actual lead involved shall be considered and the rates be reduced proportionately.
- The contractor/agency shall have give the detail of their Bank account and RTGS No. and also supply the photo copy of PAN No. so that E-payment machanism be made properly otherwise no payment will be made without RTGNo.
- The Conditions of defect liability period as conveyed vide Chief Administrator HSAMB Panchkula memo No. 5806-40 dt. 18.06.2015 will be applicable on demand Bank guarantee amounting to Rs 4,66,994/- which is @5% of Estimated cost Rs. 93,39,871/- Lacs will have to be deposited within 21 days from the date of allotment of work.

Your agreement stands concluded with the issue of this allotment letter, however a formal agreement on non-judicial stamp paper of appropriate value is to be executed by you within seven days in the Division Office from the date of issue of this letter, otherwise your earnest money will be forfeited without notice.

You are advised to contact the Sub Divisional Officer, HSAM Board, Narnaul for taking Nishandhi at site of work and for further instructions to start the work immediately.

The Sub Divisional Officer, HSAM Board, Narnaul. He is directed to follow the following points :-

- (i) Formation level should be decided and the earth work required both in case of road work as well as mandi works should be worked out before the start of work.
- (ii) The formation level should be strictly achieved at site as proposed in L-section.
- (iii) In case earth is brought from lesser lead than specified lead in the DNIT, then actual lead involve shall be considered and the rates be reduced proportionately.
- (iv) Sufficient Hume pipe/ slab culverts or cross drainage may be provided to safe guard the road from flood/rain water.
- (v) You are directed to submit the detailed estimate on allotted rates immediately.
- (vi) Revised detailed estimate based upon sanctioned detailed estimate if required must be supplied/submitted within 10 days after the date of issue of this letter.
- (vii) It should be ensured that the work should be carried out strictly in accordance with the PWD/IRC/MOST specification with up to date amendments/corrections.
- (viii) Ensure funds are deposited by the Market Committee concerned before start of work & sufficient budget may also be arranged.
- (ix) No non schedule items should be got executed from the agency without prior approval from the competent authority. Similarly no non-agreement items/other items provided in the DNIT should not be got executed without prior permission of the competent authority.
- (x) The rates for items not quoted by the agency should also be got approved from the competent authority before execution of work.
- (xi) It must be ensured that the work is executed within the amount of Admin. approval.
- (xii) Compliance of conditions imposed in the A/A conveying letter (copy again enclosed) be ensured strictly before taking up the execution of work in hand.
- (xiii) The work should be got executed judiciously, so as to ensure that the approved EXCESS on DNIT Rates/ceiling cost/analytical rates on present day does not be increased on actual execution of work even in case there is deviations/variations in quantities as approved by the competent authority at the time of approval of tender/financial statement, failing which the sole responsibility for the implications, if any, shall rest with you.
- (xiv) Items beyond DNIT & N.S. items should not be got executed from the agency without prior approval of competent authority.
- (xv) A committee consisting of Sh. Anil Kumar SDO, Sh. Vikram Singh SDO, Sh. Data Ram JE and Sh. Vikram Singh -II JE is constituted to record the NSL's in the presence of agency.
