

3	<p>Length of the proposed transmission line in forest area is mentioned 12.092 km (as per comparative statement of alternate routes). But as per details of area calculation it became 14.806 km, which is more than the other two alternatives. It may be clarified.</p>	<p>During scrutiny of proposal under Part 2, DFO Latehar suggested that Plot 161 in Ambadohar village comprising of area of 0.7011 ha is forest land and same to be added in forest proposal and forest area increased from 55.6243 ha to 56.3254 ha. Accordingly, NKTL had revised all the documents in respect of 56.3254 ha; however, effective length of forest land involved was inadvertently not updated from 12.092 km to 12.244 km wrt 56.3254 ha in comparative statement & justification. Revised Justification with the effective length of 12.244 km for Route 1 is enclosed as Annexure-3.</p> <p>Regarding discrepancy of forest length i.e. comparative statement in justification (12.244 km) Vs area statement (14.806 km); it is humbly submitted that in area statement, calculation has been done considering In & Out length of center and or outer line of corridor of forest section/patch passing through irregular shape with variable width from 1 m to 46 m of corridor for 400 kV TL wrt actual area calculated through GIS for each plot. The forest patches/plot which are passing through center line of corridor, In & Out length of center line is considered to calculate the width with actual area calculated through GIS. Similarly, the forest patches/plot which are not passing through center line of corridor and located either on left side or right side of CL line, In & Out length of outer line of corridor is considered to calculate the width with actual area calculated through GIS.</p>

Whereas in comparative statement under justification the **effective length** of route passing through forest area is calculated considering the maximum width of corridor i.e. 46 m which is the shortest possible length for all alternative explored.

Since, forest area and width of corridor (i.e. 46 m) both are constant in comparative statement of justification, whereas forest area is constant and width of corridor is variable (i.e from 1 m to 46 m) in area statement; hence there is variation in length of forest area mentioned in area statement and justification.

4 As per MoU with CCL 26.2175 ha of the forest land proposed for diversion is a part of Magadh Expansion ii, Amarpali Expansion ii and Sanghmitra Project of CCL acquired under Coal Bearing Act 1957. However, it is not clear, whether this forest land is part of any other already diverted or any other upcoming FC proposal of CCL. It may be clarified. Separated kml file of this 26.2175 ha forest land may be submitted.

- It is submitted that NKC line which start from NTPC plant, (3x 660 MW) Tandwa and terminates at 400 kV Chandwa pooling station of PGCIL has to traverse from Coal bearing area and there is no other feasible route to avoid the involvement of coal bearing area.
- The proposed route involved diversion of 56.3254 ha of forest land is the most optimal and shortest possible route which involved minimal involvement of Coal bearing area.
- The said coal bearing area belongs to CCL and NKTL had submitted the proposal for diversion of 56.3254 ha of forest land for 400 kV Tandwa to Chandwa TL of NKTL comprising of CCL land after entering into MOU with CCL and getting NOC from CCL in this regard vide letter dated 2.4.2019.
- Due to execution of said transmission project on CCL area, there shall be no loss to CCL and any loss in future, if any, shall be borne by NKTL in accordance with terms and conditions of MOU with CCL.

		<ul style="list-style-type: none">As per MOU between NKTL and CCL point no 3, "If CCL required this land for production of coal, in such situation, it is essential that 2nd party (Implementing agency i.e. M/S NKTL) will take responsibility to arrange for shifting/diverting the transmission line within 24 months subsequent upon issuance of notice by 1st party ,failing which 2nd party will be liable to pay the price of the coal to 1st party equivalent to the loss of production suffered by the 1st party due to non-diversion of transmission lines". This point makes it clear that till date ,CCL has not started any excavation work for mining purpose in land for which MOU has been done between NKTL and CCL. <p>As per available information, the aforesaid forest area is not diverted in favor of CCL yet.</p> <p>(Copy of NOC & MOU of CCL enclosed as Annexure-4)</p>


