- 4. That you shall give at least 75% employment to the domiciles of Haryana where the posts are not of technical nature and a quarterly statement indicating the category wise total employment and of those who belongs to Haryana shall be furnished to the G.M.D.I.C, Gurgaon.
- 5. That you shall get the Building plans for the site approved from the Deptt before commencing the construction at site and will start construction within six months from issuance of change of land use permission.
- 6. That no Commercial/Industrial manufacturing activity shall be undertaken at site and site shall be exclusively used for storage only.
- 7. That you shall obtain Occupation Certificate from the Deptt after completing the building within two years of issuance of this permission.
- 8. That you shall deposit labour cess before approval of building plans for additional buildings.
- 9. That you will maintain the village link road upto the National Highway and will not encroach the revenue rasta passing through the site.
- 10. That you will have no objection to acquire the land, if required for road widening.

- 11. That you will submit the clearance from MOEF, GOI under the provision of notification dated 14.09.06 before actual execution of development works at site.
- 12. That you will not raised any construction even gate, gate post and boundary wall within the area falling in road widening/green belt.
- 13. That this permission shall be valid for two years from the date of issue of this letter subject to fulfillment of the terms and conditions of the permission granted and agreement executed.
- 14. That this permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.
