





The area selected for compensatory afforestation falls under Pattan Forest (3d/D), Beat Sira-II, Block Bandhole of Dudu Range which is a degraded patch. Presently the area supports scattered trees of Deodar (*Cedrus deodara*) Kail (*Pinus wallichiana*) and Banj oak (*Quercus leucotrichophora*). Whole of the plantation of 17.0 ha will be raised in single Patch. The area identified for plantation has also been shown on the map attached. The species to be planted will be mainly Deodar, Kail and Banj oak. Total financial outlay for compensatory plantation scheme is **Rs.35,56,651/-**.
