Reference: Your office letter no. 1139 dated 22.11.2021 & letter 1090 dated 11.11.2021.



Sub: Pending Proposals with Forest Department for clearance.

Reference your letter No. 407-411/PMGSY dated 25.1.2007. In view of notification No. 50 11/CA16/27/5.29/2006/25.1.2006, you are permitted to widen the road by laying pavement within the existing road, road berm and berm slupes. No further permission is required in this respect.

It is also clarified that from the remaining land width, PWD is permitted to excavate earth and in such a manner that no loss is cause to plantation and it should be done with consultation with Divisional Forest Officer. After existing berm & slopes and if pavement is to be laid permission

under FCA 1980 will be required.
