Sub.: Regarding permission for laying of Natural Gas Pipeline of 300mm NB Carbon Steel pipeline with MDPE pipeline (as per requirement) along the NH-731 from Kathaura to Haidargarh left side for approx 22.560 km. (from ch. 77.420km. to ch. 54.860km.) and crossing at Haidergarh at Ch. 54.850Km. -reg.

This has reference to the above mentioned subject. As per request made by you for Sir, granting permission for laying of Natural Gas Pipeline of 300mm NB Carbon Steel pipeline with MDPE pipeline (as per requirement) along the NH-731 from Kathaura to Haidargarh left side for approx 22.560 km. (from ch. 77.420km. to ch. 54.860km.) and crossing at Haidergarh at Ch. 54.850Km. in the state of Uttar Pradesh, this office vide letter dated 24.08.2020 has forwarded the proposal to RO, UP East, Varanasi for soliciting approval of the Competent Authority.

The Competent Authroity at Regional Office, UP East, Varanasi has accorded approval of permission to the subject proposal with following conditions:-

a) The work shall be carried out as per proposed/approved drawing submitted with the proposal. The laying of utility along NH shall be done at the extreme edge of

b) Work programme may be submitted before start of the work and ensure timely

c) The compliance of the various undertakings given by you, should be ensured before and after signing of License Agreement, as the case may be in the interest

d) The applicant will not damage any other utility services already laid along/across the proposed route. In case of any damage then the applicant shall be fully responsible and shall pay the loss either to NHAI or concerned agency.

e) No debris/loose cart will be dumped on NH or within ROW of NH.

Applicant shal reinstate the NH to its actual condition as per satisfaction of NHAI. Cont: in pg-2-

g) The permission would be valid for a maximum of 5 years at a time, which can thereafter be considered for renewal. On payment of additional fee at the time of renewal, the permission shall automatically be renewed, unless defaults exist. In case of renewal, rate prevailing at the time of renwal shall be charged.

h) In view of any future development requiring necessary alteration, including complete removal or shifting of the utilities, the same shall be carried out by the applicant at his own cost and risk without any liability to NHAI in time bound

manner to the satisfaction of NHAI.

i) The applicant shall confirm all the standard conditions of MoRTH/NHAI's guidelines while executing the work.

The applicant shall ensure all safety measures/norms during execution of work.

k) Underground crossing must be done in the casing pipe following the Ministry's Guidelines dated 22.11.2016. Minimum depth of 1.50m from sub grade level to be maintained as per MoRTH guidelines without damaging /affecting the other structures viz. Resendential building, lelectrical lines, poles & transformers, OFCs etc. at the proposed location, and in case of unexpected event, Torrent Gas Private Ltd. Lucknow will be fully responsible for all such risk & damages.

l) The approval is based on the submissions made by the Applicant. The Applicant is responsible for the details provided in the application. The Ministry/NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the

Applicant.

m) The permission may be terminated immediately/automatically stands withdrawn on violation of the agreed terms & conditions.

In view of the above, the Approval as received from the Competent Authority, RO, UP East, Varanasi is conveyed subject to various compliances as above and NHAI/MORTH Circulars issued time to time.
