The aerial distance of proposed Gopeswar East Stone Quarry No.1 under Gopeswar RF is situated approximately 28 Km. away from the nearest Deepor Beel Wildlife Sanctuary under Guwahati Wildlife Division, Basistha.

#### **JUSTIFICATION**

The proposal for seeking operation of stone quarry of 5.0 Ha. area namely Kathalguri Stone Quarry within Kathalguri PRF under Nagaon Forest Division will enable to meet the huge demand of stone materials. The total demand of stone materials of the Division are too huge to meet from other quarry of the Division for which this site is very important. Hence, the site is selected in Kathalguri PRF for the proposed Stone Quarry to extract quality boulders/stone for use/supply in the developmental activities of Govt. Semi Govt. and also private requirement of Nagaon District. The area is completely degraded, barren and having no endangered flora and fauna, so it will not have any impact on further deterioration of environment.
