
TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (Pt.) dated 3rd August, 2009 wherein the MoEF issued Guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (FRA, for short) on the forest land Proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, It is Certified that **1.177** hectares of forest land proposed to be diverted in favour of Superintending Engineer,TDWSP,(RWS&S) Circle, Nirmal for construction of structures and laying of Pipelines in Vemanpally Segment No-22/7 of Vemanpally Reserve Forest in Adilabad district falls within jurisdiction of Suraram, Sumputam, Vemanpally & Mulukalpet in Vemanpally mandal.

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **1.177** hectares of forest area proposed for diversion. A copy of records of all consultations and meeting of the Forest Rights Committee (s), Grama Sabha(s), Sub-Division Level committee(s) and District Level Committee(s) are enclosed.
- (b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama sabha have given their consent to it.
- (c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre- agricultural communities.






