On inspection of the site the proposed project is being constructed at Barod Nallah falling on Sial Parsha Shaleen road at RD 2.900. The pipe line of the proposed project is crossing the road at 2.900 RD of the road. The site of the project is found 150 mtr. away from the road. This Department has no objection for the construction of the above cited Hydro Power Project subject to the following condition:-
