उक्त केस में प्रतिपूर्ति पौधारोपण की राशि 177290/-रु०, एन०पी०वी० की राशि 19425/-रु० मृदा एवं नमी संरक्षण की राशि 53187/-रु० तथा फेलिंग चार्ज की राशि 2904/-रु० सहित कुल 252806/-रुपये की राशि प्रयोक्ता एजेंसी से प्राप्त की जाएगी। जिसकी प्रतिपूर्ति के लिए प्रतिपूर्ति पौधारोपण Laha Sec 4 & 5 में 110 पौधे लगाकर किया जाएगी। इस प्रस्ताव में वन संरक्षण अधिनियम की उल्लंघना नहीं है।

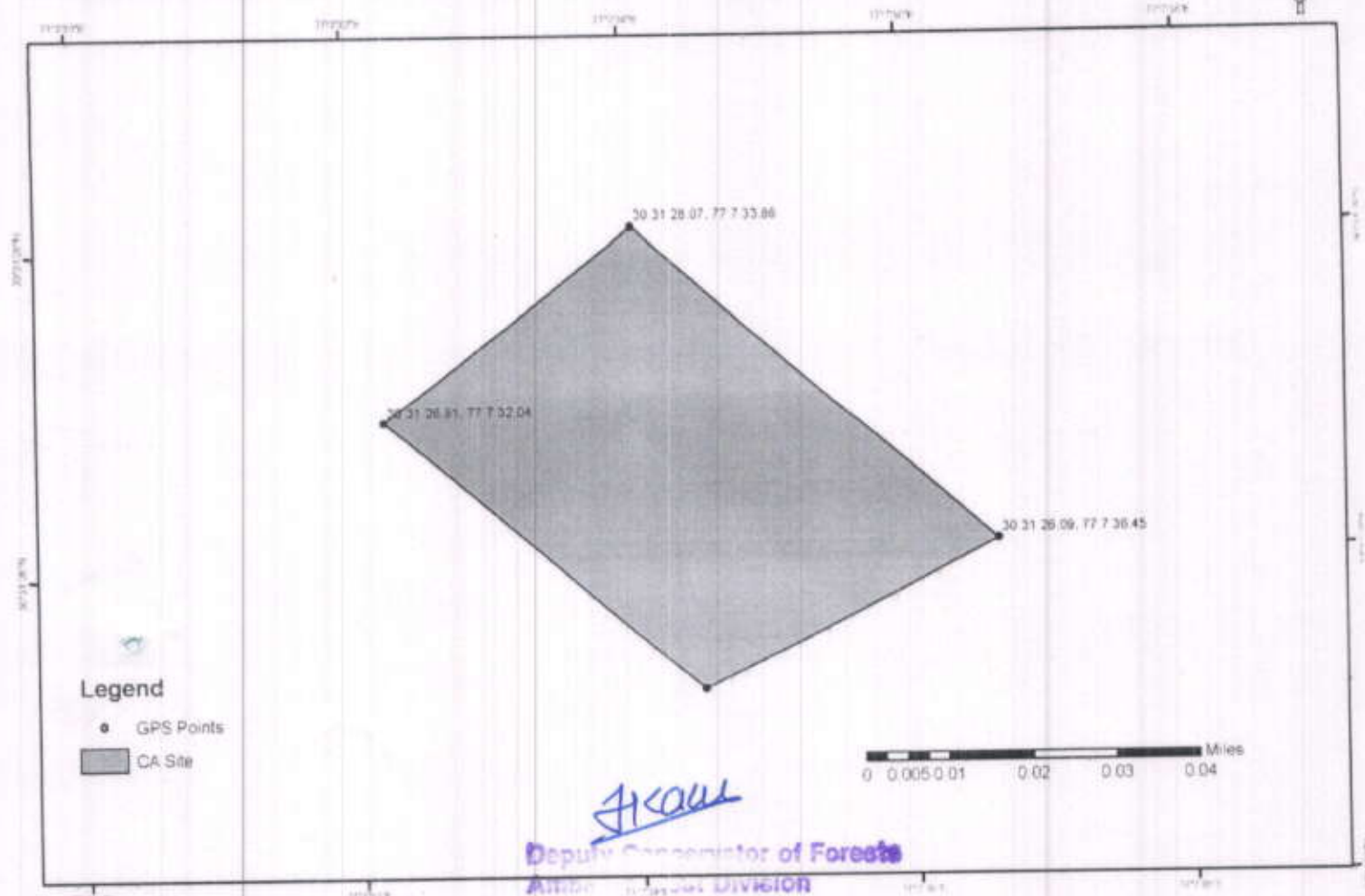

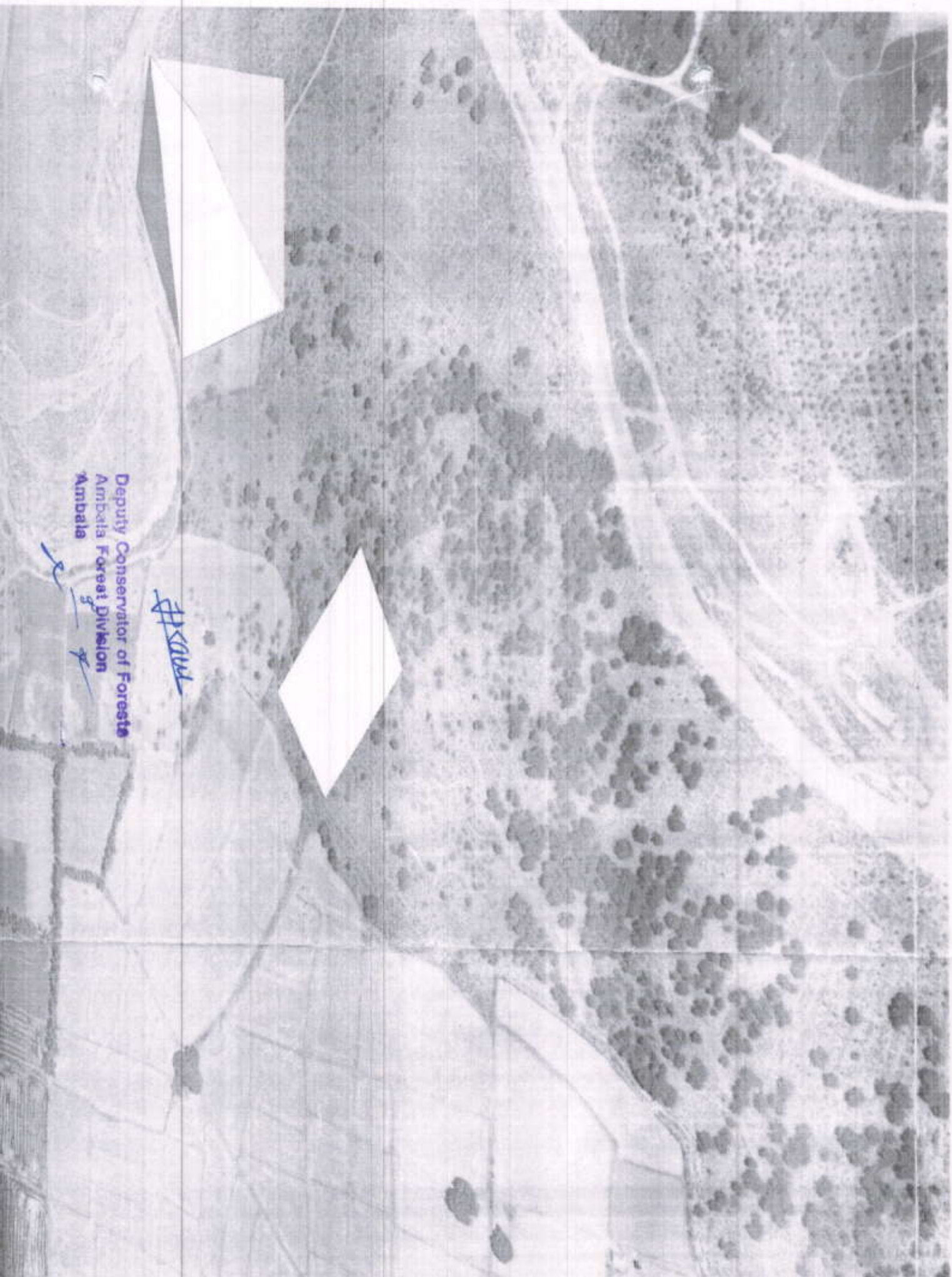
