In compliance of the Rule 6(3)(e) of the Forest (Conservation) rules, 2003[as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (Conservation) second Amendment Rules; and Forest (conservation) Amendment Rules 2016] it is certified that **29.7266 hectares** of forest land proposed to be diverted in favour of Uttar Pradesh Expressway Industrial Development Authority (UPEIDA), Lucknow for construction of "Ganga Expressway Project" (purpose for diversion of forest land) in the district falls within jurisdiction of 10 villages in 4 tehsil(s) having no recorded population of Scheduled Tribes as per Census of India 2001 and 2011.
