S.No	Observations raised by Integrated Regional Office Jammu	Rectification by this office.
01	CF's ,NO's ,DFO's and SG recommendation have mentioned 22.445 ha while the proposal is submitted for 22.45 ha this needs to be corrected.	The actual Forest area involved in the FCA proposal is 22.445 ha .The DFO/CF/Nodal officer doesn't have access to update the correct area i.e, 22.445 on PARIVESH Portal. In this regard we are sending an email to NIC- New Delhi for updation of the same.
02	DFO's submissions under column 16 of part – II recommendation letter and in online submission are Conveying different area this needs to be corrected he has also mentioned some amount on according of damage which needs further clarification .	The FCA Proposal is recommended for diversion involving forest area 22.445 ha .As for as damage Bill is concerned that needs to be removed from Column 16 of Part –II ,for this necessary correction we are sending email to NIC –New Delhi for Updation of same.
03	Persual of KML that the Alignment of the road is passing through the mountainous and steep terrain having side slope .Need to revise proposed site KML because it is 10.63 ha instead of 22.44 ha .	Corrected by User Agency.

04	DSS analysis of CA site of all the four compartments reveals that these four CA sites have plantation area of 15 Ha (NF-11 and OF -4 ha) state Govt. to provide additional CA land of 7.44 Ha.	KML File of additional CA site measuring 7.44 ha has been uploaded along with KMZ.
05	Costs benefit Anylysis of the proposal to be submitted .As per MoEF Guidelines 7-69/2011-FCA (Pt.) Dtd:- 01 August 2017.	The user Agency has mentioned "Not Applicable" As the proposal is for defense installation purpose.
