a)	As per the alternatives examined, user agency has requested BMRCL to provide the unused land in their possession for construction of proposed GLR. In this regard, it may be noted that the Regional Office, Bengaluru vide its letter dated 18th December, 2019 had accorded approval for diversion of 18.11 ha of forest land in Sy.No.1 of Kadugodi Plantation in favour of BMRCL limited for construction of Bengaluru metro Project.Phase-2	along with Range Forest Officer K R Puram Range on 16.11.2023 and it was noted that the total area was utilized by BMRCL agency and there was no unused land available.

	The State Government may explore the possession of BMRCL limited for this project.
