



Discussions on Court Matters:-

5.1 Order of Hon'ble NGT in the matter of OA NO. 548/2016 dated 29.10.2018-Compliance thereof.

The matter related to OA No. 548/ 2016 dated 29-10-2018 was placed before the SEAC, that the Environment Clearance was granted by HP SEIAA on dated 9th March, 2016 to M/s Ruma Stone Crusher, village Parchhu, P.O-Sajaopiplu, Tehsil- Sarkaghat, H.P for Extraction/collection of sand, stone & Bajri for mining area 2-00-00 hectare (Govt. land, river bed), having Khasrs no.494/457/1 (new khasra number 494/457/435/1) failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat, Mandi, H.P.

On 15th September, 2016 Sh. Achhar Singh, resident of village & Post Office-Sari, Tehsil-Sarkaghat, Mandi, H.P submitted a representation to Member Secretary-HP SEIAA regarding cancellation of Environment Clearance in favor of Smt. Ruma Devi. The representation was placed before SEIAA in its 28th meeting, wherein it was decided that the State Geologist/Mining Officer be requested to carry out site inspection and submit action taken report to SEIAA, H.P.

On dated 28th January, 2017 a case was filed by Sh. Achhar Singh, before Hon'ble National Green Tribunal, New Delhi and case petition was received in this office for reply. The reply was filed by Member Secretary HP SEIAA at NGT, Delhi in the said petition. Thereafter, the case was listed before Hon'ble National Green Tribunal in the matter of Achhar Singh vs. Union of India & Ors on 29.10.2018. In this O.A.No.548/2016, the application was disposed off with the directions from the Hon'ble Court vide order dated 29.10.2018 Annexure "A". The orders were placed before HP SEIAA on 29.01.2019, wherein it was directed that the project proponent be asked to clarify his/her contention/position in the matter of the order passed by the Hon'ble Tribunal vide order dated 29.10.2018. In response, the letter was received from Smt.Ruma Devi, the project proponent, seeking clarification of the representation filed by Sh. Achhar Singh.

After seeking comments from project proponent the matter was again placed before SEIAA and it was decided that the Member Secretary may decide the matter in accordance with the facts in question as contended by the applicant in the said petition, which may now be placed and an appropriate decision can be taken.

In compliance to the order of the Hon'ble NGT and after considering and examining the application of Sh. Achhar Singh, the authority gave an opportunity of being heard to the applicant, asked both the parties for personal hearing in the said petition. On hearing the parties at length and continuously giving reasonable opportunity(s) to reaffirm and rebut the averments. The Member Secretary SEIAA passed detailed order vide no. HP SEIAA/2015/411 on dated 15.11.2019, a copy of which was supplied to both the parties.

& Color

As per the order passed by Member Secretary SEIAA the averments of the respondent with respect to column No. 24 (Whether there is any litigation pending against the project and/or land in which the project is propose to be set up) and mining plan and environmental sustainability, thereof, and above all the directions of Hon'ble NGT, dated 29.10.2018 the authority directed that the matter may be referred to SEAC for re-examination for their recommendations and the same be forwarded for decision to the SEIAA for consideration.

After deliberating upon the matter by the SEIAA in its 46th meeting held on 07.02.2020 decided that the case may be referred to SEAC w.r.t. the three issues raised before the Hon'ble NGT as per the detailed order passed by the Member Secretary, SEIAA dated 15/11/2019.

On the directions of the SEIAA, the SEAC discussed the matter in its 73rd meeting (8th - 10th June 2020) and observed that the project proponent vide letter dated 8/6/2020 has requested the Committee to grant time of 4 weeks in view of COVID-19 situation in the matter so that he is heard. The matter was deferred after deliberating on the matter and considering the request of the respondent proponent.

The case was, thereafter, listed before the SEAC in it 74th meeting on dated 1st September, 2020. The following order of the Hon'ble NGT dated 29.10.2018 placed before SEAC, Himachal Pradesh for discussions:

".....Only grievance of the application is that while seeking Environment Clearance, relevant information was not disclosed in Form 1 appended to the application. The project proponent did not disclose that there was a litigation pending. The project proponent also did not disclose that there was no valid forest clearance on the dated of hearing. It is however, not disputed that subsequently forest clearance was obtained.

While on the face of argument, we are unable to say that Environment Clearance is per se illegal. We permit the applicant to move the authority granting the clearance so that the facts which were not placed by the project proponent and which may now be placed can be appraised and on such appraisal, an appropriate decision can be taken. The applicant may be put forward his objections within one month and decision in this matter may be taken two months thereafter. The application is disposed of......

As per the directions of SEIAA in the above matter and the order of Member Secretary

(SEIAA) dated 15-11-2019 the SEAC examined the matter and observed that the Forest Clearance was granted by Ministry of Environment, Forest & Climate Change, Govt. of India in favour of the project on dated 18th December, 2015 and the Environment Clearance granted in favor of M/s Ruma Stone Crusher, village Parchhu, P.O-Sajaopiplu, Tehsil-Sarkaghat, H.P for Extraction/ collection of sand, stone & Bajri for mining area 2-00-00 hectare (Govt. land, river bed), having Khasrs no. 494/457/1 (new khasra number 494/457/435/1) failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat, Mandi, H.P.was granted by HP SEIAA on dated 9th March, 2016 in no manner can be termed as illegal. The

The information provided in the Form I w.r.t. pending litigation it is submitted that as per knowledge of SEAC there was no litigation pending against the unit w.r.t. illegal mining on the said khasra number 494/457/435/1 failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat at relevant point of time.

SEAC has appraised the case as per procedure and all codal formalities have been completed.

On the basis of above fact, the SEAC observed that the Environment Clearance was granted after consideration of all the valid documents placed before the SEIAA, Himachal Pradesh. Therefore, the Environment Clearance is per se legal.

After deliberating on the matter, the SEIAA decided to issues an order in the matter on following lines with a copy to all concerned:

DRAFT ORDER

Whereas, matter related to OA No. 548/ 2016 dated 29-10-2018 was placed before the SEAC, that the Environment Clearance was granted by HP SEIAA on dated 9th March, 2016 to M/s Ruma Stone Crusher, village Parchhu, P.O-Sajaopiplu, Tehsil- Sarkaghat, H.P for Extraction/collection of sand, stone & Bajri for mining area 2-00-00 hectare (Govt. land, river bed), having Khasrs no.494/457/1 (new khasra number 494/457/435/1) failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat, Mandi, H.P.;

Whereas, on 15th September, 2016, Sh. Achhar Singh, resident of village & Post Office-Sari, Tehsil-Sarkaghat, Mandi, H.P submitted a representation to Member Secretary-HP SEIAA regarding cancellation of Environment Clearance in favor of Smt. Ruma Devi. The representation was placed before SEIAA in its 28th meeting, wherein it was decided that the State Geologist/Mining Officer be requested to carry out site inspection and submit action taken report to SEIAA, H.P.;

Whereas, on dated 28th January, 2017 a case was filed by Sh. Achhar Singh, before Hon'ble National Green Tribunal, New Delhi and case petition was received in this office for reply. The reply was filed by Member Secretary HP SEIAA at NGT, Delhi in the said petition. Thereafter, the case was listed before Hon'ble National Green Tribunal in the matter of Achhar Singh vs. Union of India & Ors on 29.10.2018. In this O.A.No.548/2016, the application was disposed off with the directions from the Hon'ble Court vide order dated 29.10.2018 Annexure "A". The orders were placed before HP SEIAA on 29.01.2019, wherein it was directed that the project proponent be asked to clarify his/her contention/position in the matter of the order passed by the Hon'ble Tribunal vide order dated 29.10.2018. In response, the letter was received from Smt.Ruma Devi, the project proponent, seeking clarification of the representation filed by Sh. Achhar Singh;

Whereas, after seeking comments from project proponent the matter was again placed before SEIAA and it was decided that the Member Secretary may decide the matter in accordance with the facts in question as contended by the applicant in the said petition, which may now be placed and an appropriate decision can be taken;

Whereas, in compliance to the order of the Hon'ble NGT and after considering and examining the application of Sh. Achhar Singh, the authority gave an opportunity of being heard to the applicant, asked both the parties for personal hearing in the said petition. On hearing the parties at length and continuously giving reasonable opportunity(s) to reaffirm and rebut the averments. The Member Secretary SEIAA passed detailed order vide no. HP SEIAA/2015/411 on dated 15.11.2019, a copy of which was supplied to both the parties. Copy of the order is at Annexure "B";

Whereas, as per the order passed by Member Secretary SEIAA the averments of the respondent with respect to column No. 24 (Whether there is any litigation pending against the project and/or land in which the project is propose to be set up) and mining plan and environmental sustainability, thereof, and above all the directions of Hon'ble NGT, dated 29.10.2018 the authority directed that the matter may be referred to SEAC for re-examination for their recommendations and the same be forwarded for decision to the SEIAA for consideration;

Whereas, after deliberating upon the matter by the SEIAA in its 46th meeting held on 07.02.2020 decided that the case may be referred to SEAC w.r.t. the three issues raised before the Hon'ble NGT as per the detailed order passed by the Member Secretary, SEIAA dated 15/11/2019;

Whereas, on the directions of the SEIAA, the SEAC discussed the matter in its 73rd meeting (8th - 10th June 2020) and observed that the project proponent vide letter dated 8/6/2020 has requested the Committee to grant time of 4 weeks in view of COVID-19 situation in the matter so that he is heard. The matter was deferred after deliberating on the matter and considering the request of the respondent proponent;

Whereas, the case was, thereafter, listed before the SEAC in it 74th meeting on dated 1st September, 2020. The following order of the Hon'ble NGT dated 29.10.2018 placed before SEAC, Himachal Pradesh for discussions:

".....Only grievance of the application is that while seeking Environment Clearance, relevant information was not disclosed in Form 1 appended to the application. The project proponent did not disclose that there was a litigation pending. The project proponent also

did not disclose that there was no valid forest clearance on the dated of hearing. It is however, not disputed that subsequently forest clearance was obtained.

Whereas, as per the directions of SEIAA in the above matter and the order of Member Secretary (SEIAA) dated 15-11-2019 the SEAC examined the matter and observed that the Forest Clearance was granted by Ministry of Environment, Forest & Climate Change, Govt. of India in favour of the project on dated 18th December, 2015 and the Environment Clearance granted in favor of M/s Ruma Stone Crusher, village Parchhu, P.O-Sajaopiplu, Tehsil-Sarkaghat, H.P for Extraction/ collection of sand, stone & Bajri for mining area 2-00-00 hectare (Govt. land, river bed), having Khasrs no. 494/457/1 (new khasra number 494/457/435/1) failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat, Mandi, H.P. was granted by HP SEIAA on dated 9th March, 2016 in no manner can be termed as illegal. The SEAC has appraised the case as per procedure and all codal formalities have been completed. That the information provided in the Form I w.r.t. pending litigation it is submitted that as per knowledge of SEAC there was no litigation pending against the unit w.r.t. illegal mining on the said khasra number 494/457/435/1 failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat at relevant point of time. That on the basis of above fact, the SEAC observed that the Environment Clearance was granted after consideration of all the valid documents placed before the SEIAA, Himachal Pradesh. Therefore, the Environment Clearance is per se legal. Recommended extract of proceeding of SEAC meeting is at Annexure "C";

Whereas, keeping in view the observations and recommendations of the SEAC, the matter was listed in SEIAA meeting held on 26/9/2020. The SEIAA considered the matter and is of the view that the matter has been examined in detail and agrees to the recommendations of the SEAC and affirms the grant of EC in favour of project proponent i.e. M/s Ruma Stone Crusher, village Parchhu, P.O-Sajaopiplu, Tehsil-Sarkaghat, H.P for Extraction/collection of sand, stone & Bajri for mining area 2-00-00 hectare (Govt. land, river bed), having Khasrs no. 494/457/1 (new khasra number 494/457/435/1) failing in Mauza Chuhru-ra-Balh of Tehsil Sarkaghat, Mandi, H.P. dated 9/3/2016. Copy of order be circulated to all concerned.

5.2 Order of Hon'ble National Green Tribunal in OA NO. 873/2018, Sandeep Mittal Vs. MoEF&CC, Govt. of India.

The case was listed before Hon'ble National Green Tribunal in OA No. 837/2018 (M.A. No. 1549/2018 & I.A. No. 290/2019, I.A. No. 701/2019), in the matter of Sandeep Mittal Vs. MoEF&CC, where Hon'ble National Green Tribunal has passed following orders on dated 22.11.2019:-

The question for consideration is the effectiveness of monitoring mechanism for compliance of conditions of Environmental Clearance (EC) as per Notification dated 14.09.2006 under the Environment (Protection) Act, 1986. Laying down conditions for EC based on appraisal is not enough unless compliance thereof is duly monitored. Further in order dated 22.11.2019 under these points it has been mentioned below:

- That for Category 'B' projects for which compliance monitoring has been directed to be responsibility of SEIAA and SPCB, following to be taken note of:
 - a) Sanctioned staff strength and MIP of SEIAAs and SPCBs/PCCS are still not available.
 - b) SEIAA and SPCB are under the administrative control of State Government.
 - c) There is ambiguity with respect to their present involvement in monitoring of EC conditions.



 Accordingly, it has been difficult to speculate the timeframe for taking up and completion of monitoring of Cat. B projects at present.

 The SEIAAs and SPCBs have been asked to provide information so that the above timeframe may be calculated.

- Six months action plan has been prepared by the MoEF&CC for comprehensive compliance of environmental conditions.
- That as enumerated in the Action plan, the Ministry plans to carry out a thorough assessment of the quantum of work involved. Based on this exercise the following action are to be undertaken:

a) Filling up of vacant posts where applicable.

b) Creation of additional posts in all the agencies to be involved in monitoring and compliance viz.ROs, CPCB, SEIAA and SPCB; if required.

c) Hiring of young professionals as per feasibility.

d) Creation of new ROs, if required.

 Utilizing services of CPCB and SPCBs to effectively discharge responsibilities of monitoring,

f) Strengthening Monitoring Cell within the Ministry.

- g) Develop web based online mechanism to automate the entire process of inspection and compliance monitoring.
- 4. That the Action Plan provides a detailed roadmap for the coming months which includes:

a) Hiring of an Independent Agency TO ASSESS THE WORK REQUIREMENT.

- Constituton of Monitoring Evaluation Committee (MEC) to steer and supervise a new monitoring mechanism.
- Engagement of Consultant for development of web based mechanism for end to end digitization.
- 5. That in the interim, till the larger Action Plan is implemented, in order to improve the monitoring process, following actions has been/will be taken up:
 - a) Filling up on nine vacant posts of Scientists in the ROs

b) Strengthening the Monitoring Cell in the Ministry.

c) Delegation of the action on monitoring reports of Catory B projects to SEIAA as per the Notification no. SO637 (E) dated 28th February 2014.

d) Evolving a mechanism for online maintenance of monitoring and compliance data with regard to Catogary-A and Catogary -B projects and integrating it with the existing PARIVESH portal of the Ministry.

After considering the mater the Hon'ble NGT was of the opinion that the mandate of law is not complied with by the above stand of the MoEFF&CC. It is well acknowledged that there is rampant violation of the Environment Clearance conditions.

Thus, there is dire need for revamping the monitoring mechanism by MoEFF&CC as well as SEIAAs, CPCB and State PCBs Post EC monitoring processes need revamping in quantitative as well as qualitative terms. There is need to prioritize the projects where potential environmental degradation is high on account of nature of activity as well as area being ecological sensitive.

MoEF&CC is the monitoring agency who looks after the required standards of the environment clearance who further submits the 6 months report to the DEST and PCB. On the behest of the MoEF&CC the monitoring is conducted as the other Authorities don't have a legal backing and adequate staff to furnish the activity of monitoring.

Therefore the Hon'ble NGT have asserted that if there is an EC regime, compliance has to be monitored. The principle of Sustainable Development and the Precautionary principle, which have been held to be part of 'Right to life', require that EC conditions are fully complied.



Further, the Hon'ble NGT is of the view that for meaningful monitoring, all category-A projects are monitored not less than twice in a year and all category projects are monitored not less than once in a year. Let the Secretary, MoEF&CC and Chairman, CPCB hold a meeting with such other experts as may be found necessary and establish and/or augment the institutional steps in MoEF&CC, CPCB and SEIAAs for meaningful monitoring of category A and B projects in the light of the above observations.

The orders passed by the Hon'ble National Green Tribunal in OA NO. 873/2018, Sandeep Mittal Vs. MoEF&CC & Ors. was placed before SEAC in its 74th meeting held on 1th Sept., 2020 for discussions.

The SEAC after detailed discussions observed that:

- SEAC agrees to the fact that the compliance of conditions imposed in the Environment Clearance required to be monitored at State level as has been envisaged in the order.
- 2. An effective monitoring mechanism is required to be devised by the MoEF&CC, GoI.
- 3. Monitoring of EC conditions may be made mandatory with provision to submit the monitoring reports duly audited by authorized/approved auditors of MoEF&CC, GoI.
- Adequate manpower and resources may also be provided for the purpose of EC terms and conditions monitoring.

The HPSEIAA deliberated upon the observations of the SEAC on the orders issued by the Hon'ble NGT. The Authority was of the view that the SEIAAS & SEACs are constituted by the MoEF&CC, GoI as per the provisions of the EIA, Notification, 2006 with specific mandate defined therein. At present concerned Regional Offices of MoEF&CC, GoI are monitoring the EC conditions and taking necessary action. Therefore, the MoEF&CC, GoI may issue clear cut directions & guidelines to the SEIAA & SEACs. However, in order to implement the orders of Hon'ble NGT the following suggestions from SEIAA, Himachal Pradesh may be communicated to the MoEF&CC, GoI:

- The SEIAAs are required to be strengthened by developing a robust post-EC monitoring mechanism with advanced technological know-how.
- The compliance of conditions imposed in the Environment Clearance required to be monitored at State level as has been envisaged in the order.
- 3. An effective monitoring mechanism is required to be devised by the MoEF&CC, GoI.
- Monitoring of EC conditions may be made mandatory with provision to submit the monitoring reports duly audited by authorized/approved auditors of MoEF&CC, Gol.
- Adequate manpower and resources may also be provided for the purpose of EC terms and conditions monitoring.
- Requirement of funds may be mobilized by imposing processing/ user charges to the projects applying for grant of Environment Clearance on polluter pay principle. State Government should be authorized to lay charges.
- 5.3 Order of Hon'ble NGT in the matter of Appeal No. 40/2019(WZ) Marvada Amrutial Becharlal & Anr. Versus Gujrat State Environment Impact Assessment & Ors. -Compliance thereof.

The matter is related to appeal No. 40/2019(WZ) Marvada Amrutlal Becharlal & Anr. Versus Gujarat State Environment Impact Assessment & Ors., whereas per orders passed by Hon'ble National Green Tribunal dated 01.09.2020, it has been directed that:-

.....EC is at times obtained by the project proponents without disclosing complete and correct information, SEIAA must cross check and verify the information furnished by the project proponent independently so that the safeguards for which EIA has been provided by the law can be ensured. Absence of doing so is leading to avoidable damage to the environment and public health............

The Hon'ble NGT orders dated 01/09/2020 were discussed by the Committee in its 75th meeting. The Committee agreed to the directions of the Hon'ble NGT, and observed that in order to ensure the compliance to the directions in the matter an undertaking shall be taken from the project proponent and the consultant to the fact that:



"... I have gone through the content presented in the application are correct and any wrong information provided by me shall be liable for legal action as per the law."

The Committee also observed that in HPSEIAA the practice of deputing sub-committee to cross check and verify the information whenever felt necessary already exists and may be further strengthened.

After deliberating on the matter & recommendations of SEAC, the SEIAA accepted & approved the recommendations of the SEAC to the fact that project proponent signs undertakings submitted along with FORM-I at the time of submission of application. However, the documents submitted by the project proponent may be cross verified from the concerned issuing authorities.

Item No. 6

The matter related to approval sought at later stage specifically in government projects was deliberated at length by the SEIAA. The SEIAA expressed its serious concern on the omissions of not seeking timely approvals in such government owned projects due to which the environmental concerns are not being attended appropriately. The SEIAA decided to write a letter to the State Government for issuing an advisory to all such concerned department who are undertaking large developmental projects or construction projects exceeding 20,000 sq. mtrs. Including the existing buildings to seek prior Environment Clearance as applicable to such projects. Experts of an environmental committee /SEIAA are not in a position to contribute anything in the project for better environmental management practices at a later stage to ensure and compliance to the environmental standards.
